



On Thursday, February 13, nine CANE members chained themselves together in protest at the Western Addition Redevelopment (RDA) office. Providing support outside of the office were 100 spirited picketers.

RDA has been in Nihonmachi since 1960. Since then RDA has, house by house, block by block evicted and destroyed our community. Last week RDA evicted a family from their low rent house at 1772 Sutter Street. RDA boarded it up and plans to destroy it. In its place will go expensive apartments which Nihonmachi residents cannot afford. This is the latest example of RDA's crimes to the community.

We cannot let this upheaval go on. At stake are our homes, our families, our livelihood, and our historic ties. CANE's action on Thursday was to expose to all RDA's crimes. **WE SHALL NOT BE MOVED!** We will continue to take a stronger stand for the residents!

WE ARE DEMANDING

1. That RDA not demolish the empty building at 1772 Sutter, which it has boarded up and quarantined and wants to replace it with high rent apartments.
2. That RDA immediately repair the building **and** make it liveable for use by families needing low-rent housing.
3. That RDA repair for use as low-rent housing other empty buildings within the Nihonmachi area, such as 1622 Laguna Street.
