

SUGGESTED PROGRAM FOR NEW YORK HEARING

Throughout the hearing the coordinating committee had felt it was important to have a good balance between community testimony and "expert" testimony. The Commission has expressed particular interest in hearing more Issei, more about New York Nikkei experience, about the relocation process itself from those who were actually involved in it, from Japanese Latin Americans, and Seabrook

The hearings have all been organized by panels of people speaking in the same general topic area. Set forth below are the panels which the program committee and coordinating committee were able to come up with. I have taken the liberty of organizing the panels into morning and afternoon sessions.

MORNING

Japanese American Organizations: This panel would be composed of member organizations of ECJAR who wish to give testimony as a group - JACL, CJA, NY Buddhist Church, JA United Church, JAHFA, Niko Niko, 442 Veterans, Hastings people?

Politicians: Should be self-explanatory.

East Coast Experience This would include Nikkei who were not evacuated, people who relocated here.

Religious/Moral Issues: This panel would address the religious and moral issues of the concentration camps and express their views on redress & reparations:

Reparations/Redress: This panel would make specific recommendations for r & r and possibly address the legal precedents for redress and reparations.

Issei: Issei panel would include Ellis Island detention, round up of Issei and Issei internees.

AFTERNOON

Sociological/Psychological: Panel of sociologists and psychologists who could address the impact of the camps from that angle.

Seabrook: The Commission has expressed particular interest in the Seabrook experience and our understanding is that there are 10 firm commitments to testify from Seabrook.

Sansei: Sansei or Yonsei could speak to what they feel the impact of the camps has been on them, particularly Sansei from the east coast when there is no community.

Resettlement/Relocation: This panel would be composed of people who were involved in the actual relocation and resettlement of people into this area.

Scholars: Much work has been done as to the atmosphere of the time - the political, social and international context for the internment of JA's. Scholars from this area have contributed to that body of knowledge:

East Coast Experience 2: There will probably be more Nisei who would want to testify from the list of suggested and potential testifiers listed before and others not known at this time.

Human/Civil Rights/Legal: New York has a wealth of human and civil rights organizations. We had thought to draw on some of those resources to speak to the human and civil rights aspects of the camps.

Other Asian Community Support: These would be short statements of support from different Asian organizations who support r/r.

Labor: If there are labor organizations that have taken a position on r/r they could speak here.
