Harold Stimson had persuaded Biddle

Gordon Hirabayashi - quiet, conscientious student - on high moral principal - refused to go to camp -
Viol of curfew

~~Fred Korematsu~~ - because he loved someone
Dec. 1944. Sustained evac. Sup. Ct. decision

June 1943 - because of "peculiar racial affinities" -
evacuation was justified.

Japan, sub + navy off the coast of U.S. 1943. Before, during, after Pearl Harbor. No espionage or sabotage.

3/ Peter Irons - Univ. of Mass. Found numerous documents - many arguments presented in '40s were not true.

"Because of inscrutable characteristic, etc (by DeWitt) thus - "emergency measure"

* Radio transmission was checked; impossible Japan didn't have radios. Radios were already considered contraband 792 transmitters. ^{examined + traced} Not one was illegitimate. Yet a report issued to Supreme Ct.

* Writ of Coram Nobis

To re-open case. No statute of limitation; even after one is in jail. As long as there is evidence of injustice, case can be re-entered.

Munson Report - "People are pathetically loyal; 100% loyal." Yet 442/100th Bn.

Important principle makes distinctions on the basis of ancestry - no one chooses ancestry -
