The National Committee for the Defense of Political Prisoners is a collective of concerned Brothers and Sisters from a variety of organizations (N.Y Counsulate of The Republic of New Africa, El Comite, Black Liberation Party, Black Panther Party, Lincoln DeTox, OPO) and community People genuinely concerned about the plight of our Brothers and Sisters incarcerated in amerikkka's concentration camps (prisons).

The purpose of this communication is to seek out some answers to some criticisms we have for the defense committee's, groups, and individuals, etc; alledgedly working with political prisoners and prisoners of war. These criticisms entail your failure to organize support around Comrade Elmer "Geronimo" Pratt, Comrade Ruchelle Magee, and other prisoners of war especially on the west coast.

It has come to our attention that you have taken a slipshod attitude insofar as supporting P.O.W in the courts, by not visibly supporting these Brothers at their trials. The banning of respective memberships to attend trials by members in leadership capacities, failure to follow through with committments after making them, a reluctance to organize demonstrations, speaking engagements, rallies, etc; in the Brothers behalf. These positions you have taken are very productive, reactionary and counter-revolutionary. It also illustrates a lack of enthusiasm for revolutionary struggle.

If your failure to support these P.O.W are a product of the split within the Black Panther Party, provoked by opportunist-revisionist Huey Percy Newton and the Peralta St. gang; how are you going to deal with the pig's if you cant deal with babylons edition of Magsaysay of the Phillipines?

The truth of the matter seems to lie in your fear of getting involved based upon personality, stardom, celebritism, and evaluation. We suggest that you begin to deal with these problems with a more revolutionary view, or relinquish your role as political blockers in the oppressed Black and Third World communities.

## WHAT'S HAPPENING IN THE COURTS?

Except for the celebrated cases like Angela Davis...Continuous frameups, railroading, wild charges, filmsy testimonies, denial of motions, refusal of appeals and skyrocketing bails.

Let's remember that thousands of unheralded, unknown brothers and sisters who cannot afford lawyers are being sen; to concentration camps everyday and forgotten. We cannot let this happen to:

RUCHELL MAGEE--(Prisoner of War) "You(America) are playing dangerously sick games at the wrong time with human lives, and you are not and cannot hide this case no longer". Ruchell Magee.

The case of Ruchell Magee dates back to 1963. He was convicted and sentenced to life in prison for supposedly stealing \$10. The story of Ruchell's life was one of going to jail and getting out. A life lived in and out of jail from the time he was 13 years old. It is with this knowledge that it is very easy to understand why on Aug. 7th, 1970 when Jonathan Jackson came into the courtroom and made a bid for the freedom of his brother, George Jackson, and the other members of the Soledad Brothers, Ruchell Magee took this opportunity to try to liberate himself.

Ruchell Magee, along with James McClain, William Christmas and Jonathan Jackson - took hostages ( Judge Haley and the Asst. D.A. and others) out to a van in the parking lot! The pigs were only concerned with stopping the brothers. When the shooting stopped. three of the brothers were dead plus the judge... RUCHELL SURVIVED...

After the pigs had shot and killed Jonathan Jackson, William Christ-mas and James McClain along with Judge Haley, they had to have someone to put the blame on. Ruchell was the only survivor so he became the scapegoat.

Ruchell is scheduled to start trial on this case on August 1st. He needs your support. He is defending himself on the same charges that Angela Davis was just acquitted of.

Some of the brothers and sisters that are behind these bars are political prisoners and others are prisoners of war.

POLITICAL PRISONERS are all Black and Third World people who because of racism and capitalism are oppressed and thereby commit acts of survival. Some examples are:
