

### **VA NEWS**

William Oshiro, urges veterans, widows and parents to promptly return income questionnaires receives last November, even though the January 15 deadline has passed. Information from the questionnaires is used to adjust pension benefits. Questionnaires were mailed to veterans on VA pension rolls, widows of veterans drawing pension based on nonservice-connected deaths, and parents receiving dependency and indemnity compensation for service-connected deaths of sons and daughters. Pensioners 72 years old or older who have been on pension rolls during the last two consecutive years generally are exempt. However, they still must report changes in income, and those who were mailed questionnares must return them. Each year, thousands miss the deadline because the questionnaires are forgotten or lost, causing interruption or delays of monthly benefits checks.

### VA NEWS

More college students have already received educational benefits under the current G.I. Bill than were trained during the entire World War II G.I. Bill program, reports William Oshimo. During October, nearly 801,000 G.I. Bill college students were enrolled. This surge pushed the cumulative total during the seven years since the newest G.I. Bill was enacted to 2,258,158 trainees. The October college enrollment includes 5,785 in Hawaii, 256 in Guam and 75 in American Samoa.

College trainees under the current G.I. Bill include 91,312 servicement and 2,166,846 veterans. Military personnel on active duty were not eligible for training under the two earlier G.I. Bil Bills.


In terms of percentage of all G.I. Bill trainees who trained at the college level, only 28.6 % of the World War II veterans went to college. That percentage jumped to 50.7 % for the Korean G.I. Bill, and to date stands at 56.1 % for Vietnam-Era veterans.

A major reason for the big increase in college level training today is the higher level of preservice education attained by present day veterans. During World War II only 38.5 % of servicemen had completed high School. Some 85% of the Vietnam-Era servicement were high school graduates, and thousands of others were able to complete high school training under military educational programs while in service.

\*\*\*\*\*\*\*\*

The Veterans Administration has initiated new measures making it easier for married veterans to qualify for guaranteed home loans. In consideration of current social and economic patterns, VA will hereafter recognize in full the income and expenses of both the veteran and spouse in determining ability to repay a loan obligation. The VA is required by law to determine if the contemplated terms of repayment bear a proper relation to the veterans' anticipated income and expenses before approving a loan.

The spouse's income has always been considered for this purpose, but in the past, local rules which had the effect of discounting the young wife's income were often imposed. Under the new policy, no such local rules will be imposed and the wife's income will be given full consideration.

### **VA NEWS**

Wide ranging medical legislation which became effective on September 1, extends Veterans Administration medical care to certain dependents, gives peacetime veterans the right to VA medical care and streamlines rules on health care delivery for the rest of the veteran population. In addition to a number of administrative provisions, the law extends eligibility for medical care to the wife or child of a person who has a total disability, permanent in nature, resulting from a serviceconnected condition, and to the widow or child of a person who has died of a serviceconnected condition. Care will be provided in a manner similar to that in which medical care is furnished by the armed forces under the so-called "CHAMPUS program" to dependents and survivors of active duty and retired personnel. The law removes the requirement for wartime service as a condition of eligibility for VA medical care.

cars.




### VA NEWS

Increased benefits will be reflected in February Veterans Administration pension checks for nearly 2.7 million disabled veterans and survivors of deceased veterans.

A cost-of-living increase in these VA benefits is authorized by law signed by the the President earlier this month. The increase will show in checks dated February 1 which will cover January pension payments.

Highlights of the new law:

- \* Maximum pension payable to veterans without dependents increased from \$30 to \$50 monthly, if hospitalized more than two months.
- \* Pension for veterans with no dependents and income of not more than \$300 annually increased from \$130 to \$143 monthly.
- \* Pension for veterans with one dependent and incomes of not more than \$500 annually increased from \$140 to \$154 monthly.
- \* Widows with no dependents and incomes of not more than #300 annually increased from \$87 to \$96 monthly.
- \* Death pension rates for children increased from \$42 monthly plus \$17 monthly for each additional child, to \$44 monthly plus \$18 monthly for each additional child.
- \* Authorized lumpsum payment of \$25,000 to certain veterans discharged from the Army as a result of an incident in Brownsville, Texas, or \$10,000 to their unremarried widows.

The Veterans Administration urges veterans who haven't done so to "advise survivors of benefits they're entitled to from the agency in event of your death." William Oshiro, Director of the Honolulu Veterans Administration Regional Office, emphasized that "failure to do so could cause undue anguish during times of great emotional stress."

It's a good idea for veteran and spouse to sit down and openly discuss important family matters, including locations of family documents, which would facilitate filing of claims for VA benefits. Military discharge papers, divorce decrees, guardianship or child custody evidence, birth, marriage and death certificates should be kept safe from fire and theft, yet readily accessible.

Oshiro said other important details include keeping track of G. I. and commercial insurance policies, "C" numbers from VA correspondence, Social Security numbers and naturalization papers. Veterans also were advised that in event of death, the deceased's family or close friends should know they can check with veterans service organizations, as well as VA offices, for information and other assistance.


#### CONVALESCENCE


