
THE PRESIDENT'S MESSAGE








VA NEWS

REVISED VA BENEFITS PAMPHLET

The newest edition of a basic VA pamphlet, 'Federal Benefits for Veterans and Dependents' (IS-1 Fact Sheet), has been distributed to the agency's field offices and is on sale by the GovernmentPrinting Office.

The 1976 edition of the 57-page publication reflects the latest information and changes in VA benefits programs, including medical care, pension, disability compensation, home loans, life insurance, burial benefits, education and vocational rehabilitation programs and dependents' education assistance.

The pamphlet also summarizes certain benefits for veterans administered by other federal agencies. These include Labor Department job finding assistance, Civil Service job preference and Small Business Administration loans.

The "IS-1 Fact Sheet" features a handy timetable indicating time limits on applying for benefits, and it contains a list of VA offices to which applications should be sent.

Addresses of all VA facilities, including hospitals and alcoholism and drug abuse treatment centers, are also included.

Copies are available for 95 cents from the Superintendent of Documents, Government Printing Office, Washington, D.C. 20402.

VA BURIAL BENEFITS FOR VETERANS' DEPENDENTS

Former service men and women have been urged to acquaint members of their families with the Veterans Administration burial allowances available for veterans. William C. Oshiro, Director of the VA's Honolulu Regional Office, said the benefits can ease the financial burden of the veteran's family.

For example, the VA will provide a payment of up to \$250 toward the burial expenses of eligible veterans. An additional \$150 is payable as a plot or interment allowance when burial is not in a National Cemetery or other cemetery under United States Government jurisdiction.

Burial or plot allowances are paid to funeral directors and cemetery owners if burial costs are unpaid, otherwise the proper claimant is the person who bore the expense of funeral and burial.

In case the veteran's death is service-connected, payment of an amount not to exceed \$800 will be made. This payment is made instead of the usual burial and interment allowance.

Burial is available for all eligible veterans at all National Cemeteries except Arlington. Burial in these cemeteries is also available to an eligible veteran's spouse, minor children and under certain conditions, to unmarried adult children.

VETERANS ADMINISTRATION

QUESTIONS AND ANSWERS:

- Q. I have a \$10,000 National Service Life Insurance policy which I converted to a 20-payment life several years ago. I would like to assign my policy to my bank. Is this permissible?
- A. No. Government life insurance policies are not assignable by the insured, nor may the insured divest himself of ownership.
- Q. Does my VA compensation check, for a serviceconnected disability, include allowances for my children?
- A. If the service-connected disability is rated at 50 percent or more, the amount of compensation will include amounts for all qualifying dependents that have been reported to the VA.
- Q. Can a veteran receive community nursing home care at VA expense?
- A. Nursing home care servi ce at VA expense is limited to veterans whose condition is service-connected veterans who are unable to defray the expense.
- Q. What monetary benefit is available to a widow of a serviceman who died on active duty?
- A. Dependency and Indemnity Compensation will be paid the widow based upon the m-litary pay grade of her deceased husband. She also is entitled to educational benefits.
- Q. If I am hospitalized for treatment of my service-connected disability, how is my VA compensation affected?
- A. If you're hospitalized for more than 21 days, your disability rating will be increased to 100 percent until the last day of the month of hospital discharge or termination of treatment or observation for the disability.
- Q. How much will the VA pay me for enrolling in a correspondence course under the G.I. Bill?
- A. Eligible veterans may be reimbursed 90 percent of established charges for the number of lessons completed by the veteran and serviced by the school. Payment is made quarterly.
- Q. The VA has terminated my husband's pension payments, reason 'whereabouts unknown." Is there any way I can be paid his VA pension

since I only receive Social Security payments?

- A. Possibly. After 90 days the veteran's pension may be paid to a wife if a claim is filed within one year following date of last payment to the veteran. The amount paid will be that received by the veteran or the amount of death pension, whichever is the lesser.
- Q. I served on active duty for two months. Am I eligible for admission to a VA hospital?
- A. A veteran who has served at least one day of active duty other than for training purposes and discharged under conditions other than dishonorable is eligible for VA hospital care.
- Q. I have been advised that if I change the optional settlement of my G.I. life insurance policy from option four to option one, my wife who is my principal beneficiary will gain flexibility of payment that she does not have now. Is this true?
- A. Yes. Option one enables the beneficiary to elect that option for settlement or any other option that pays over a longer period.




