## ALOHA BRUYERES By John Tsukano

When KHET - Hawaii Public Television airs "Aloha Bruyeres" next month, be sure to see it from the beginning.

The first five minutes are so absorbing that you will sit transfixed before the television screen wishing that the film would go on and on and never stop. It is guaranteed to transport you back into time, lift you soaring through the gamut of emotions and send cold chills through your entire body.

The powerful, heartrending docudrama opens with a bird's eye view of the fog-shrouded Vosges Mountains and forests, looking so menacing and foreboding. The rare, black and white war time film discovered in the National Archives in Washington D.C. then proceeds to show the 100th and 442nd in action in and around Bruyeres, France, in October

You'll see a young Chaplain Higuchi waving goodbye to his men as they disappear into the dark forest, for many, forever. You'll see the animal-like reflex action of the men of the 100th and 442nd as they charge from one tree to another, the entire AJA epxerience etched in their faces. You'll see the medics attending their mangled bodies, some of them so torn by shrapnel that the officials of the Public Television were compelled to delete them. One of the saddest parts of the 5 minute segment shows the men of the 100th and the 442nd searching for the names of comrades on the temporary, wooden white crosses after a memorial service. Recognizable in the film are many who, themselves, died in subsequent battles.

With Copeland's masterpiece "Fanfare for the common man" as musical background, the flashbacks firmly establishes what "Aloha Bruyeres" is all about and sets the tone for the next 55 minutes of the docudrama.

The stark war time film shows a squad of 442nd soldiers gazing down on war ravaged Bruyeres from the top of a hill. This acutely painful scene gradually turns into color and shows the Bruyeres of 1978 from the very same spot. The transformation is dramatic and startling, and so is the message of the docudrama.

From something horrible something beautiful

Of particular interest to 100th Battalion veterans will be the segment showing Young Oak Kim where he describes the feelings, emotions and spirit of the men of the 100th and the 442nd who fought in the battle of Bruyeres and Biffontaine.

Sandy Holck tells about the beginning of the sister city relationship between Bruyeres and Honolulu, The Kailua High School Madrigal Singers pay tribute to the 100th and 442nd by their superb performances at church, at a concert in Epinal and at the 442nd memorial in the forest. The Madrigals, composed of the many races that make Hawaii, have now become a fixture in Bruyeres every summer where they are considered "family"

Don't miss seeing "Aloha Bruyeres". It will make you proud. And there are other sur-

Today's topic is titled "How to travel economically while silently enduring all the inconveniences not associated with firt class commerial conveyances". Or, "Go Space 'A', but don't lose your cool even though a 1000 & 1 thing can and will befall a military space 'A' traveler", who, hereafter will be known as S.A.T. Ruth and I were two such SAT's during New Years. We thought it would be interesting to see how my kinfolks in Yamaguchi-Ken celebrate New Years. We found out how interesting.

After inquiring at passenger information, Kadena AFB on Christmas Day, we were informed that there will be an aircraft from the Philippine passing thru Okinawa to Iwakuni, Japan and points east on the 30th of December. Terrific! That should get us there before New Years Eve and we can ring in the New Year with hot sake on the rocks. Now this is the tricky part so pay close attention. You don't want to book-in too early and be called to go out on an earlier flight. You won't be there, consequently they'll remove your name from all flights unless you book-in again. Show our travel orders, passports, leave form and I.D. Then over to Border Clearance and to baggage check. Here, another Airman makes out our boarding passes and we pay \$10 each. It's not free anymore. We wait and wait and at 1430 the P/A blares that the flight is delayed to 1600 due to

non-arrival of the aircraft. If this didn't happen, I'd be forced to change my concept of the old "hurry-up and wait" military system. But true to form they did not disappoint. The Flying Tiger military charter arrives at 1630, 2 hours late. We line up to go thru the metal detectors manned by the Air Police, file into a waiting room where the hand-carry bags are searched. We are exempt from this search because we are only leaving the Japanese Province and not the country. When everyone had passed the scrutiny of the AP's we then file out to board the aircraft. Seat belt fastened and all ready to take off? Oh no! We are not to slip the surly bonds of earth yet. The stews go up and down the aisle counting heads over and over. They count but still come up with one extra head. Finally, everyone must show their boarding passes and lo & behold, there's a Marine stowaway who is sitting in the plane nonchalant about the furor he's causing. They quickly escort the no-SAT off the aircraft and one-half hour after boarding the aircraft, we go off into the wild blue yonder.

We reach Iwakumi, Japan, about 2130 after a  $l_2$  flight. Oh, but that  $l_2$  hour trip took us  $8_2$  hours from the time we checked in. So what did you expect? I told you earlier that its cheap, didn't I?

Well, too late to catch the train for an hour's ride to Iwata where my uncle lives. Besides its too cold to stay outside--temperature being in the low 40's. We check into the Hostess House on base for \$4 a night. Hey--now that's my idea of travelling economically.

The following day Dec. 31 being Sunday, we couldn't find any place on base to eat breakfast. We catch the train and head for my uncle's, sans breakfast. We get off about 2 stations before Iwata at the city of Yanai. The idea is to stay at a western-type hotel because the last time we were at my uncle's Ruth couldn't use the flush toilet (flush with the floor). Me too, I get the awful fear that my wallet will drop out of my hip pocket and fall into the hole. On the last day of our visit, it fell. Not my wallet. My second cousin dropped her slipper. It was recovered but for obvious reasons, I didn't ask for details. Well, anyway we jump into a cab and ask to take us to a western-type hotel. He couldn't find any that is open. The Japanese people have closed business for the 3 days of New Years. The cabbie radios back to the dispatcher but they couldn't help either. Akishamio'. We're in the cab already so "take us to Iwata." When we got there the fare was \$21 give or take a few yen. Imagine spending \$21 and Ruth never got to use a western-type toiNew Year's eve in Japan should be a rousing time with all the kinfolks gathered together and partying-up, so I thought. Ruth and I spent the night huddled around the Kotatsu watching "Utodaigassen" on the TV. This thing about Kotatsu. The feet and hands are warm alright but the back is cold. Also my back ached. From sitting on the floor so much. The program ended about midnight and by then everyone was off to bed and the house was quiet. No firecrackers, no shouting "Happy New Year," no goodies on the table.

New Year's day the whole family got together and that's when we got hit by the young people. The kids really make out if they got lots of relatives and this year there were two more from Hawaii. The Japanese call it "Otoshi Dama". I call it something else which is not as polite.

Afternoon was spent by going to the Omiya and lighting some incense, reading fortune written on tissue papers and tying them onto a tree branch. Finally rang a great big gong and took leave to visit the Kintai Bridge at Iwakumi.

The Kintai Bridge is a tourist attraction and the place was crowled even with the chilly weather. The young people were all out promenading in their finest-especially the young girls all dressed up in kimonos. Very pretty sight. The kimonos were pretty too. The bridge? Oh, about 200 years old, built in 5 arch spans without nails. Did they have magic glue during those days? On both banks of the bridge were countless cherry trees with buds ready to bloom in a few weeks. That's when we should be there, we're told. The cherry blossom admirers will be out by the droves for Hana Matsuri, picnics under the cherry blossoms, drink sake and fight. Towards dusk, we got home and spent a quiet night.

On the 2nd day, it was time to take leave of the rural life and head back to Iwakumi Base to catch an early flight the following day. That is when the goodies came out. Kinda spartan compared to what we're used to back home. Roast chicken, turkey, tempuras, fish, sashimi, etc. Compared to the fares here, I'm convinced that the American people eat so much better to a point where what's commonplace to us, is a feast to these people. As a gesture of appreciation, for their hospitality we took 3 of the young second cousins and treated them to steak dinner at the NCO club on Base. Seeing the appreciative look in their eyes was a feast for our soul too.

The trip back to Okinawa was routine and uneventful. 'Routine' is riding in a C-141 cargo jet along with the cargo lashed down in the same compartment. The jet noise is so unbearable, they give each SAT's wax to stuff into the ear.

### THE PINE TREES OF ST. RAPHAEL

The tracks of the wheezy old electric train ran along the French coast of the Riviera, between St. Raphael and Toulon: along the curved beaches of fine white sand studded with brightly colored beach umbrellas and gaily decorated cabanas, great luxury hotels, palm-lined boulevards; past the airports and harbors and naval enclaves; and, in and out of the great pine tree forests which covered the entire coastline.

Then early one morning, an awesome armada of ships appeared off the coast and the 15-mile horizon between St. Raphael and Cape Benat (which lies about halfway between St. Raphael and Toulon) was blackened by over fifteen hundred Allied ships - for this was the 15th of August, 1944 - and Allied planners had picked this date, and the stretch of beaches between these two towns, as the jumping-off points for Operation Anvil, the Allied invasion of Southern France from the Mediterranean.

Allied aircraft had been softening-up the whole coastal area for weeks but the thick pine forests provided excellent camouflage for German batteries encased along the hills and beaches in anticipation of just such an invasion attempt. And to counteract landings from the air, the Germans had felled a number of pine forests whose tree trunks were about a foot in diameter. These were cut into 12-foot lengths, then one end filed into needle like pointed spikes. They were then set in holes dug in the ground to cover every bit of open field, designed to impale paratroopers and gliders alike.

All the beaches along the Riviera provided excellent landing points but the determination of the St. Raphael-St. Tropez area was for the reason that the cape west of St. Tropez contained a battery of four 13.4-inch guns capable of firing eight volleys a minute at a range of 20 miles. The batteries were encased in 10-inch armor plating and to knock out these guns before the start of any invasion would have entailed a most Herculean task.

Allied planners had anticipated that St. Raphael would become the main zone of action. And so it was. Long after the German guns along the other beach sectors had been silenced, the guns of St. Raphael continued to repulse the invaders; U.S. divisions which, from right to left, were the 36th, the 45th and the 3rd. So when the 36th Division hit the beaches in and around St. Raphael that morning, they were driven off by the counterfire from German guns still in effective operation. Despite this, General Dahlquist, the division commander, was the first division commander to set foot on the invasion beaches that morning.

(it was the 36th, it will be recalled, which took such a horrible beating at Cassino, along with the 100th and other units stuck in "Purple Heart Valley" through the winter and spring months of 1944.)

(You will also recall Senator, Daniel Inouye, in his book "Journey To Washington", telling of Gen. Dahlquist's reaction to the rescue of his "Lost Battalion" in Bruyeres. The general had called out the 442nd in a retreat parade to thank the men for their rescue efforts in the hills above Biffontaine. As he looked over the parade ground, he asked how come only so few were assembled. When told

that this was all that was left of the regimental combat team . . . . "Gen. Dahlquist looked at us for a long time. Twice he started to speak and choked on the overpowering feelings that took hold of him. In the end, all he could manage was an emotional, 'Thank you, men. Thank you from the bottom of my heart.' And the saddest retreat parade in the history of the 442nd was over.")

The 100/442 had been pulled out of Italy and arrived in Marseilles a month-anda-half after the start of Operation Anvil. It was then trucked up the Rhone



River valley to the northeast corner of France to fight the battles of Bruyeres-Biffontaine. Afterwards, what was left of the combat team was pulled back, in mid-November, to the southern coast of France where it was engaged mostly in border patrol actions. It was the period of the "Riviera holiday" in the Nice/Menton areas.

It was during this prolonged period that members had time to explore other cities and town dotting the vacation-land seascape. The place names on the accompanying map should evoke many a memory; perhaps, even of St. Raphael. Why St. Raphael?

About 15 years ago, the Sate of Hawaii Department of Land and Natural Resources began a program to establish pine tree plantations in many places in the islands as a method to stop soil erosion, but also for the purpose of determining whether the logging of pine trees could be developed into a new industry for Hawaii. In recent years, some of the forests of pine have become infested with predators. In its efforts to combat the predators, the Division of Forestry of the Department of Land and Natural Resources has, among its many contacts, received help from the European Parasite Laboratory of the U.S. Department of Agriculture whose offices are near Paris, France. The entomologist from that office has made several shipments of parasites to Hawaii and these seem to be doing a better job of combating the predators than antagonists brought in from other parts of the world. (In this respect, the Division of Forestry is not certain but has suspicions that the predators could have come to Hawaii through Japanese bonsai plants.)

The entolomogist in France has offered this observation concerning the shipments of parasites to Hawaii: "They (the parasites) all come from St. Raphael, on the southern coast of France. Actually the trees were in the small park set aside as a monument at the invasion beach where the Americans landed in August 1944. Maybe it is somewhat fitting that the material from there should find its way back to the United States."

Enter Victor Tanimoto, forest entomologist with the Division of Forestry. (Victor had an uncle in the 442nd, Larry Tanimoto, who was killed in action.) In following up on the observation of his counterpart in France, he has come to the Club 100 and the 442nd Veterans Club wondering whether any of their members may have recollections of St. Raphael. If so, Victor would like to add a touch of human interest to his official reports on the progress of his office in combating the local pine tree infestation problem.



## **VETERANS ADMINISTRATION**

### VA HELPS LOWER COSTS OF REMEMBRANCE

The Veterans Administration is now permitted to reimburse a veteran's survivors for part of the money they spend for an eligible veteran's headstone or marker in any private cemetery.

This is one of the provisions of the Veterans Housing Benefits Act of 1978 recently passed by Congress and signed into law by President Carter.

Survivors now have a choice of getting a VAsupplied headstone or marker or one they choose from a commercial supplier. The VA reimbursement, however, cannot exceed the average amount VA pays for the headstone or markers it supplies. Currently this amount is estimated at about \$43.00, far below the average cost of headstones or markers on the open market.

For those who choose to have a headstone or marker provided by VA, the agency now has the flexibility to provide headstones or markers of any material (marble, granite, bronze, slate or other) asthetically compatible with the cemetery in which it is to be located.

Assistance in filing applications for reimbursement or for headstones or markers can be obtained at any VA office. Applications for reimbursement must be forwarded to the nearest regional office. Applications for headstones or markers must be forwarded to Director, Headstone Service, National Cemetery System, Veterans Administration Central Office, Washington, D.C. 20420.

Max Cleland, Administrator of Veterans Affairs, reminds survivors that VA may reimburse them also for part of the burial expense for an eligible veteram. The new amounts are \$1100 if the death is service connected and \$300 if it is not. These amounts are in addition to \$150 plot allowance if the veteran is not buried in any national cemetery.

## ANNUAL REPORT REQUIRED FROM PENSIONERS OVER 72

Benefits Counselors from the Honolulu VA office are standing by to provide any assistance requested by elderly pensioners who this year must complete a Veterans Administration Annual Income Report to qualify them for higher pensions.

Beginning January 1, 1979, about 813,000 pensioners--over the age of 72--must complete the full VA income questionnaire annually. The over

72 group was exempted from such reports in the past.

VA Chief Administrator Max Cleland said the agency is taking extra steps to provide any assistance to these older veterans and surviving spouses may need in completing the questionmaire.

One reason for the new reporting requirement is that the law permits those already on pension rolls to choose between the current and a new system of computing pension. Also, the income of both spouses is considered in determining pension eligibility. Among other changes the new law raises the amount a pensioner may receive from other sources and still qualify for VA pension.

Benefits Counselors in VA and veterans organizations will help individuals to choose the system that best suits them. VA is requiring its personnel to recommend to each pensioner the system that is most advantageous to them.

Administrator Cleland emphasized the importance that older veterans understand that they cannot receive pensions in 1979 unless the completed questionmaire on income is returned.

"We found through a survey," he said, "that some veterans were not taking advantage of certain allowable exemptions from income that might qualify them for higher pension. Others apparently did not understand that they were obligated to report changes in income."

## VOLUNTEERS NEEDED

Volunteers are needed at Honolulu's VARO Outpatient Clinic located at the New Federal Building.

The clinic is a modern, well-equipped facility providing full outpatient services to many of Hawaii's 94,000 veterans.

Director William C. Oshiro of the VA Regional Office said veteran patients at the clinic need those extra pairs of helping hands to care for their needs. Volunteers will help in the reception areas, pharmacy, laboratory, Mental Health Clinic, X-ray Services and provide other personalized services.

Persons who want to help veterans by joining VA's Outpatient Clinic volunteer team are asked to contact Harold D. Saurer, VA Voluntary Service Room 2215, Federal Building, 300 Ala Moana, telephone 546-2195.

## VA ADMINISTRATOR CITES 1978 SERVICE TO VETERANS

More emphasis on priority medical care for service disabled veterans, an improved pension plan for low-income disabled veterans, and an improved home loan program--these were some of the highlights of 1978 veterans benefits, according to Veterans Administration Chief Max Cleland.

Congressional action went far to make 1978 a banner year for veterans, Cleland said.

In the closing weeks of the 95th Congress, legislation was enacted improving the VA pension program for veterans and their survivors.

Beginning January 1, 1979, this legislation sharply increases payments to needy veterans with nonservice-connected disabilities, and their survivors, from the present subpoverty level to variable payments supporting income levels of as much as \$6,781 a year for a veteran and his wife, plus \$600 a year for each child.

At the same time the Act calls for eventual savings by limiting pension payments to the truly needy.

Other legislation with broad support provided a 7.3 per cent increase in VA compensation payments for more than two-and-a-quarter million veterans, a quarter of a million surviving spouses and 92,000 children of deceased veterans.

The year also saw:

\*\* A special \$900 monthly allowance to allow certain seriously disabled veterans to employ a skilled health care practitioner whose aid and attendance in the home is necessary to keep the veteran out of the hospital;

\*\* A special monthly payment of \$175 for veterans who suffered a service-connected loss of one extremity or its use, and who have subsequently lost the paired extremity from nonservice-connected causes;

\*\* A new payment of \$45 monthly for surviving spaces receiving disability and indemnity compensation benefits and who are so disabled as to be confined to their homes;

\*\* A broadening of the eligibility base for allowances to dependents of veterans with serviceconnected disabilities. The allowance will be paid to veterans with 30 per cent or more disability, whereas it formerly went only to veterans who had 50 per cent or more disability.

The GI Bill continued to be a major attract-

ion among VA's varied benefits program. More than 1.6 million veterans, their dependents and active duty servicemen and women pursued a variety of educational goals under the program.

In Fiscal Year 1978, VA spent \$3.2 billion on education benefits under what has easily been one of the most popular programs ever conceived by the Federal Government.

In another area, VA opened two new national cemeteries during 1978 with the dedication of Calverton National Cemetery on Long Island, New York, and Riverside National Cemetery in California, the latter on Veterans Day.

The two new cemeteries are the first in a VA program to expand the National Cemetery System, which currently consists of 105 cemeteries across the nation.

The agency has already acquired land in Massachusetts, Pennsylvania and Virginia for additional cemeteries, and is now considering sites in the Great Lakes and southeastern areas of the country for two more.

During 1978, VA took the first steps to computerize the agency's files on veterans. Regional offices in 13 cities were linked via a computer system called TARGET with Data Processing Centers in Illinois and Texas.

In 1979, VA hopes to place the remaining 45 regional offices into the computer network, which now contains about five million compensation and pension records and an index and locator file on approximately 30 million veterans.

Full computer processing of benefits claims is expected by the end of next year.

Cleland said he was particularly proud of the agency's special project to provide distinctive personal identification cards to more than two million service-disabled veterans.

"Veterans disabled in military service are of prime concern to VA," he said. "These special D cards will expedite the care they receive at VA Medical Centers and will serve as a constant reminder to our employees as well as to veterans themselves that they are special people entitled to special care from their government."

The VA Administrator also cited the agency's "Operation Better Letters" and "May I Help You?" campaigns as examples of internal efforts at improving employee awareness of the unique role veterans and their dependents hold in the nation.

Both projects involved major efforts to stimulate employee helpfulness and courtesy in dealing with veterans and their families and Cleland termed both of them as "outstanding successes."

VA and the Congress also cooperated in 1978 to provide more assistance to veterans in the area of home ownership.

The VA guarantee on home loans was increased to \$25,000 from \$17,000 and the active duty time needed by Vietnam Era veterans to qualify for VA home loan benefits was reduced to 90 days from 181 days.

Also, Cleland pointed out, VA is now permitted to guarantee loans on apartments converted to condominiums, where previously the agency could only guarantee loans on condominium units that were built as such.

VETERANS AUTHORIZED TO PAY DISCOUNT ON VA REFINANCING HOME LOANS FOR PURCHASE OF FEE SIMPLE ESTATE

Donald E. Austin, Loan Guaranty Officer, Honolulu Veterans Administration Regional Office, amounced today that "where the veteran is an occupier and leaseholder seeking to refinance an existing mortgage or other liens and to buy the fee to the same property, and is otherwise eligible for a loan guaranty, he may pay all of the reasonable discount points required by the lender." Austin said he received approval from VA Central Office, Washington, D.C., on December 22, 1978.

Austin received approval on February 3, 1978 for a veteran-leaseholder who is purchasing the fee to have his entitlement restored conditioned on the existing guaranteed mortgage being satisfied or the Administrator otherwise being released from liability.

Both of the above exceptions are made specifically for the veterans in the state of Hawaii.

Veterans should contact a lender of their choice to make application for this purpose.

## MR. MAX CLELAND SPEAKS

Veterans Administration chief Max Cleland today outlined the magnitude of the agency's assistance to Hawaii's 94,000 veterans in a speech to members of the Honolulu Rotary Club.

A triple amputee veteran of the Vietnam Era, Cleland said VA amnuallly spends more than \$66 million in Hawaii -- a state whose veterans have wisely used the various benefits available through the agency.

For example, he said, more than 80 per cent of all Hawaiian veterans of the Vietnam Era have used their right to GI Bill training.

Nearly 7,000 of them are currently in training, he said, and more than 36 per cent of the state's Vietnam Era veterans eligible for the GI Bill have used it to go to college.

VA is currently spending more than \$2 million a month in Hawaii for GI Bill training.

A comparable amount, Cleland said, is being paid monthly to veterans and dependents in VA compensation and pension benefits.

. Recipients are veterans -- or survivors of veterans -- who suffered disabling injuries or illnesses in service, or who receive assistance from VA because later disabilities have left them unable to earn a living for themselves.

Cleland also pointed up the fact that VA's loan guaranty program has been a popular and successful one in Hawaii over the years.

In the past year approximately 2,800 home loans were guaranteed in the state, bringing the total to date to more than 21,000 loans with a value of \$641 million.

Cleland said 25,000 Hawaiian veterans hold VA insurance policies with a total value of \$220 million. More than \$2.6 million in insurance dividends were paid last year.

The VA Administrator said excellent military hospitals in Hawaii provided care for 768 VA patients last year. He said the agency's outpatient clinis in Honolulu recorded some 36,000 patient visits last year and that VA paid for 6,500 treatment visits to private health facilities.

Of the National Memorial Cemetery of the Pacific, Cleland said the agency's future development and improvement plans will protect what he termed "a national treasure" and promised that it would be preserved as "the lovely, useful place you know now."

### NEW DISABILITY COMPENSATION PAYMENT

Veterans Administration Chief Max Cleland has alerted disabled veterans to a provision of a new law that could mean an additional \$175 a month in VA compensation payments to them.

The added payments are authorized by "The Veterans Disability Compensation and Survivors Benefits Act of 1978." which was recently signed by President Carter.

In general, veterans eligible for the additional payment are those who suffered the service-connected loss, or loss of use, of one extremity and who have subsequently lost the paired extremity from nonservice-connected causes.

The veteran must have been rated less than 100 per cent disabled by VA for his service-connected injuries to be eligible for the newly added compensation for nonservice-connected loss.

Currently, the average monthly VA compensation payment for a veteram with service-connected loss of a leg, or its use, is \$211.

Administrator Cleland said VA is issuing a special appeal for assistance from national veterans organizations in locating disabled veterans who may qualify for the new benefit.

"Our computers can identify veterans who have service-connected loss of extremities, but we have no way of knowing how many of them have subsequently lost a paired extremity from non-service connected causes," he explained.

The VA Chief also urged any disabled veteran who believes he might be eligible for the additional payment to contact the nearest VA regional office or one of the veterans organizations.
