"Shadow" Seichi Hirai died January 11, 1982, after a short bout with cancer at Kuakini Hospital. He was stricken while on a trip to Japan in late November and was hospitalized until his death.

Cannoneers remember "Shadow" with great clarity even after the passage of time for he was never one to sit in the background. After the war he completed his law studies at the University of Hawaii and George Washington University.

He began his career in 1956 as a researcher in the office of then Delegate to Congress John A. Burns and became assistant to the Clerk of the Senate in 1958. Since 1963 he was the Senate Clerk. In his position, Shadow was an expert in the ways of the state Legislature and was a key inside figure in Senate politics.

When the State Legislature convened on January 20 for the 1982 session, Shadow's seat was empty and a huge red carnation lei was draped over the seat he had held for someny years. Both Houses of the Legislature dedicated the opening sessions to the memory of Shadow. Do not cry for Shadow - he would not have wished it. Even his funeral service was private on January 15 followed by burial at Punchbowl National Cemetery.

Shadow is survived by his wife, Beverly; daughter, Colleen who is an attorney; mother, Shizue Hirai; brother, Albert of Illinois; sisters Ayako and Mrs. Joe (Janet) Hirota.





According to TORO HIROSE, NORMAN KURLAN testified on November 23, 1981, the the "Commission on Wartime Relocation and Internment of Civilians."

'My name is Norman Kurlan. I served as an officer with the Anti-Tank Company of the 442nd Regimental Combat Team since its inception in 1943. You have heard a great deal about the valor of the 100th Infantry Battallion and the 442nd Regimental Combat Team. I can attest to the validity of every word...because I was with them from start to finish. ...Let me return to 1943. While the 442nd was training at Camp Shelby, Mississippi, I visited the Jerome "Relocation" Camp in Arkansas. There I saw Americans of Japanese ancestry incarcerated behind barbed wires. As an American of Jewish heritage, the experience was shattering...the bitter irony is that while the unit was fighting in Europe and suffering great casualties...(some 9,500 purple hearts)... the families of the Mainland Nisei were interned in American-Style concentration camps. In conclusion...to right the wrongs committed against

the Japanese Americans, I strongly support the demands by Japanese Americans for redress and urge the commission to recommend the same to congress ."

This is a report from Emmet L. O'Conner, Lt. Col. Infantry (retired).

"I had the distinct honor of being one of the early selection of officers to serve with the 442nd Regimental Combat Team. At the time of selection I was assigned to the Office of Military Governor of the Territory of Hawaii with station at Iolani Palace in Honolulu."

"I was born and raised in the Territory of Hawaii and grew up among the people of Japanese ancestry as well as attending school with them. As far as I am concerned, we were all Americans.

"...These were the people, citizens of these United States in most cases, who had been uprooted from their homes and herded like so many cattle to the so-called "Relocation Centers."

"...We were at war with Germany and Italy as well as Japan, yet only those of Japanese ancestry were imprisoned. Their people had committed no acts of sabotage nor were they, or had they been guilty of spying for the enemy. Questions for which I had no answers.

"...0f their parents, in many cases second and third generation removed from Japan. Of brothers and sisters who had been swept out of college and herded off to live as prisoners. The young soldiers were confused as to why their people were being treated as they were.

"...There is no way that the United States of America can fully and justly compensate the thousands of men, women and children who were so despicably treated by our government during World War II. The loss of personal property, homes and businesses as serious as they were, are nothing compared to loss of pride, the loss of faith in the country and the shame of being kept and treated as prisoners while their young men were going off to die for the country that was keeping the Nikkei imprisoned."

1981 ANNUAL REPORT OF THE BOARD OF DIRECTORS TO GENERAL MEMBERSHIP, 442ND VETS CLUB FCU

Your Board of Directors is once again very pleased to report another successful year with new highs in practically every phase of our operation:

- 1. The Credit Committee reported new record in loan activity and substantial improvement in delinquent loans.
- 2. The Treasurer's Report shows we are nearing the \$1 million size in assets; savings are at all-time high; our reserves and undivided profits stand at better than 14% of risk assets; and our income sources are well balanced with net earnings at the highest level ever.
- 3. Because of these excellent performances, your Board has declared a 12% dividend for the fourth quarter of 1981. This 12% is the maximum allowable by Federal credit union laws. Dividend for the first three quarters was at 7% -- the maximum set by Federal regulations.
- 4. Although most of our loans on the books yield us only 9%, our investments in money market certificates and time deposits have earned in the range of 12 - 16%. Thus, this makes it possible to pay our savers better than average dividends.
- 5. In order to adequately "reward" our savers who have made possible the lowest loan rates anywhere available to our members, your Board increased all loan classes by an additional 1%. This means our rate schedule will show new ranges of 10 - 13% which still may be the lowest in the country among financial institutions.

Even though we have said it before, your Board again wants to give thanks and much appreciation to the following volunteers who run our credit union:

As expected, the average size of loan made in 1981 increased to \$3,541 from last year's \$3,006. The total amount loaned last year represents a new high. While auto loans continue to be our major loan class, home improvements rank as our number two.

Five delinquent loans aggregating \$3,243 were written off against reserves previously established. However, these accounts have been turned over to an outside collection agency. We expect to make recoveries on these bad debts. On the other hand, we are pleased to report that as of December 1981, we only had two delinquents with balances totaling \$4,900 as compared to 17 and \$20,995 one year ago.



- ${\tt Q}$ I am interested in starting my own business. Does the Veterans Administration provide business loans to veterans?
- A No. The VA does not provide business loans for veterans. Such loans may be available through the Small Business Administration. Check the "U.S. Government" section of your local telephone directory for the address of the nearest SBA office.
- Q I am a World War Veterans who let my GI insurance lapse years ago. I recently read that a new bill passed Congress giving veterans like me a dividend on this lapsed insurance. How do I apply?
- A Any story you hear about insurance dividends for lapsed Veterans Administration insurance is only a false rumor that occasionally spreads in different parts of the country. The only insurance dividends currently being paid by the VA are to veterans who were issued participating policies in World War I, World War II and the Korean Conflict, who have maintained the policies in premium paying status.
- Q Is there any time limit for using my certificate of eligibility for a Veterans Administration guaranteed home loan?
- A No. There is no time limit for using your certificate of eligibility for the purchase of a home.
- Q Are Veterans Administration benefits subject to taxation?
- A Almost all veterans benefits are non-taxable. However, there are two exceptions. One is interest paid on accrued GI insurance dividends left on deposit. The other is death settlement proceeds.
- Q I am a widow of a Korean War veteran who died as a result of a service connected disability before using his GI home loan entitlement. Am I eligible for this benefit?
- A Yes. If not currently married, widows of veterans of World War II and later periods who died of service connected causes are eligible for this benefit.
- Q If I encounter legal difficulties while purchasing a home using the GI Bill, will the Veterans Administration pay or provide for any legal assistance I may need?
- A No. The VA does not pay or provide for any legal assistance a veteran may need to deal with troubles encountered in the purchase or construction of a home.
- Q My husband wants to be buried in Arlington National Cemetery. What should he do?
- A This cemetery is under the jurisdiction of the Department of the Army, and burial is limited to specific categories of military personnel and veterans, except in the case of cremated remains to be placed in the columbarium. For details, write to the Superintendent, Arlington National Cemetery, Arlington, Va. 22211.




