In three weeks of fighting through the heavily forrested Vosges Mountains, the 442nd had suffered 2,300 casualties. There'll be memories of overcast skies and dark forests, drizzling rain mixed with snow, miserable cold and the devastation besides the casualties. Our thoughts and hearts will be there with all in Bruyeres.

Looking ahead to the July 1985 Nisei Veterans Reunion (NVR), the Club has received a number of concerned calls lately. For those who are planning to attend this Reunion on Maui, the registration forms should be available at the Clubhouse for redistribution to chapters within a month. #### HANDS ACROSS THE CLASSROOM by Shoichi Kimura

I am a Japanese American and a former school teacher. I am proud of these two facts, but prouder am I of the knowledge that I am a friend of Miss Elizabeth Humbargar. Who is Elizabeth Humbargar? She's an altruist, a champion of civil rights, and a humanitarian. These words by themselves are inadequate and do not do her justice, so let me elaborate.

One day in the spring of 1946, I found myself forlornly staring at the list of courses offered by Stockton College in the hall of its administration building. Almost giving up in despair, I was about to leave when a voice demurely said: "Haven't I seen you somewhere before?"

"If you have, it must have been in the dark, Ma'am, for your face is totally unfamiliar to me, I almost blurted out. Instead, realizing that here was my opportunity to receive some aid, I hurriedly stated that I was from Hawaii, that I was on my way back from overseas where I was a member of the 442nd, that I had hoped to study at Stockton College before returning, but that I was hopelessly lost and knew not where to begin.

Immediately and kindly, she escorted me to her office, drew up a tentative schedule, and had me matriculated. The efficiency with which she worked intrigued me, but what impressed me more, and very highly, was her perfect spelling of my name after hearing it but once, for ninety-nine percent of the people who had met me for the first time found my name to be unpronounceable and unspellable. She, I told myself, was not an ordinary person. She was something special. Either she had been in Japan---possibly in Hawaii, but unlikely in that she would have said something when I superficially presented my background---or she had had many contacts with Japanese in particular. At any rate, I thanked her for her help with out which I would not have been a student.

IN MEMORIAM

GEORGE S. KURIO

George S. Kurio an member of 232nd Engr/Band Chapter, 442nd Veterans Club, passed away on September 18, 1984. As the months went by, my hunch that she was unique was corroborated as information from the Japanese community about Elizabeth and her sister Catherine filled me with respect, admiration and reverence. I learned that they, as teachers at Stockton High School in the thirties, secured hundreds of jobs for the kibeis who had to have employment while in school. The kibeis, one must remember, suffered needlessly from extreme ridicule by the general public, for their speech inflection branded them as foreigners and odd, making job placement for them almost impossible. The Humbargar sisters also supplied references, commseled these students in both their school

counseled these students in both their school and out of school problems, and sponsored clubs from which scholarships for the kibeis were obtained.

After World War II started, and when all the people of Japanese ancestry in Stockton were herded into the assembly center, the Humbargar sisters showed their true mettle as they took care of the storage of property as requested by the internees; as they visited and consoled the sick who were sent to hospitals; as they established a school clearing house where all students could go to complete their courses; as they transported textbooks and supplies so the students could sustain their education; as they made arrangements with the public library to have more books available; as they wrote many, many clearance letters for those who needed them to pursue their education in the East; and as they visited the assembly center time and time again in the face of hostile and filthy opposition by bigots who were now jeering them as Jap lovers.

At this very moment, over forty years later, it's difficult to understand the tension that filled the air when the Japanese people were rushed to assembly centers; it's difficult to understand the fear that prevailed; it's difficult to recall the insecurity that gripped the people who were interned. We seem to be fairly well-off now, and consequently to fully understand the plight of the Japanese people then, one needs to go back in time to comprehend and feel the atmosphere of the forties, when discrimination and prejudice against the Japanese were rampant, in order to adequately appreciate the deeds of the Humbargar sisters. Talking recently with a few new-found friends in Stockton, I learned that many Japanese, immediately after the war started, were panic-stricken, as ugly incidents stemming from outright racial hatred occurred time and time again.

At this perilous time, Elizabeth and Catherine despite the danger of physical abuse by so-called

"patriots," realized more than ever that visits to the center were so necessary and so essential to the well-being of the people that they stead-fastly ignored the threats of harm and continued to meet the interned who, desperately, at this particular period in history, needed someone, needed something to believe in. To the Japanese, vital to their sense of belonging was the need to know and to be reassured that there were people who cared; that there were people to whom the word democracy meant what it implied though, seemingly, the walls of democracy were crumbling.

During the evacuation years, to uplift the morale of their former students, Elizabeth and Catherine wrote letters by the thousands to those who were in relocation centers. They wrote innumerable notes of references for jobs as the requests came in; they furnished dozens of complimentary reports to the FBI as soon as the young miseis were called to join G2 groups; they wrote to many colleges, chastising them about the attitude of the schools and their lack of acceptance of niseis The time they spent on this 'work,' which to them was absolutely necessary and proper, can never be measured.

When the military authorities allowed the nisei soldiers to return to California, the Humbargar residence in Stockton served as a virtual USO for the G.I's, as hotel rooms and restaurants, among other things, were "unavailable" to them.

To the young, heart-broken, and disillusioned Japanese from Tule Lake, who lived in mortal fear of returning, there had to be a spark of hope in America, their country. There had to be someone they could trust. There had to be some they could depend on. But where was this hope to be found? One of the places was at 936 South Country Club in Stockton!

As the internees fearfully and slowly returned, the Humbargars housed as many as they could, found jobs for them, aided them in resettling, and more important, convinced them that our Constitution still meant liberty and justice for all.

Elizabeth and Catherine are now retired from teaching, but their work still goes on. There are more jobs to obtain, more letters of recommendation to write, and more friends to make and help.

In my personal case, after seeing that I was enrolled, Elizabeth found me a job in the school library. Offhand, this act does not sound like much, but when one realizes the number of jobs denied me, and when one is made aware of the fact that I was refused membership in a union simply because of my ancestry, one can easily understand, I'm sure, what a gift from heaven this job was.

Then, during my senior year, when I was doing my student-teaching, she got me placed as a full-fledged adult education instructor, the first Japanese American to do any sort of teaching in Stockton, causing a little news in the tiny Japanese community.

Following my graduation, she pooled a group of willing professors from the College of the Pacific to write glowing letters of recommendation for me, and she valiantly fought to have me placed in the Stockton Unified School System. Unfortunately, several die-hard members of the board of education refused to budge, as they resisted having the color barrier destroyed.

Undaunted, Elizabeth made an appointment with the superintendent of schools in Oakland, drove all by herself from Stockton to Oakland, a mean feat considering the hazardous roads then and her ineptness in driving, and convinced the superintendent that qualified Japanese Americans should be accepted in the teaching profession. Superfluous to say, without Elizabeth's aid, I would never have obtained a job.


If one were to multiply what Elizabeth did for me by a hundred--nay, by a thousandfold--one would get a small picture of what a beneficent person she is!

As I write this, I am fully aware that her health is not up to par. What a fine gesture it would be if her former students, as well as people who do not know her but who appreciate the highest in Americanism, would drop her a line at 936 South Country Club Blvd., Stockton, Ca 95204, and acknowledge her kindnesses.

How appropriate it would be if the 442nd, with its well-known logo, could issue her a certificate, recognizing, thanking, and commending her for her humanitarianism, courage, and actions in bettering the lives of the Japanese in Stockton, especially during a time of turmoil, danger, and need.

What do you think, gang?

Seventy Seven former members of Easy Company, 442nd Regimental Combat Team were guests of one of their own VIP, U.S. SENATOR DANIEL K. INOUYE, at Kanraku Teahouse on August 25, 1984. It was a dinner given by the former field commissioned officer who went up the ranks from private to Captain and is also the holder of the Distinguished Service Cross he won for heroism in the field of battle. In the words of the Senator he decided to invite all his former buddies of FASY COMPANY to honor the contributions of the 442nd RCT in commemorating the 25th anniversary of Hawaiian Statehood. He considers the record of the 442/100 on the battlefields of Italy and France was a direct factor in Hawaii's successful statehood fight. When you consider the fact that both leaders of the United States Senate and the House of Representatives were Texans and the role the 442nd played in the rescue of the lost Texas 36th Division, Majority Leader Lyndon B. Johnson and Speaker of the House Sam Rayburn were Hawaii's two strongest boosters in Congress.

Dan of course, was most pleased to see so many at the dinner. Dan being originally from the 1st platoon, the platoon that has just about the lowest membership in the Chapter brought out the greatest number for the dinner. Dan also was the leader of the 3rd platoon and this is the platoon which is the core strength of the Chapter also brought out a sizable number to the dinner. The man we use to call "Pop", TOSHI ANSAI who led the Company as its 1st Sergeant during the early part of the war in Italy, used the mike to give his words of wisdom which has always been welcome since the days he was like all of us, a private in Uncle Sam's army. Being considerably older than most of us young volunteers, Pop was always available like a father or uncle to all who needed and wanted help and counsel. CHARLEY ARAKAKI discussed the 1985 Nisei Veterans Reunion which the Maui 442nd Veterans Club is hosting. The man whose monicker was Balloon, DAN AOKI, is balloon no more also took the mike and bellowed his feelings like he used to give orders to the new recruits as a 1st Sergeant. S.T. STOOKA OOKA was not amused with AOKI's bellowing so that put Aoki's use of the mike to dim and low.

Almost forty years after wars end the men of "E" Company still look good. Yes, there are a few who put on some unneeded weight but generally the physique of the then young volunteer of 1943 is still fit for battle. Age and a helluva load of public service has taken a toll on "Pop" ANSAI. He looks tough physically but admits that his eye sight is slowly leaving him.

One other reason for the dinner in Dan's thoughts was the need to recruit more former "F" Company boys to join Easy Chapter of the 442nd Veterans Club. Present membership is 36 and as the years creep up there will not be too many years left to meet old buddles unless you're a member of the chapter or you meet at services for the departed. The friendships forged in training and battle get dearer and dearer as one ages. Easy Chapter membership provides one an opportunity to meet once a month at chapter meetings and sometimes at chapter dinners. At the first Chapter meeting following Dan's dinner CHICK TESHIMA was the only new member who signed up. There is work to do here.

Finally, "POPS" TOSHI ANSAI made a very timely speech thanking DAN for inviting the gang to dinner that night. On behalf of Easy Chapter of Honolulu and all former "E" Company veterans the writer would like to take this opportunity to thank the Senator for the lavish dinner and the fine thoughts that went with it. He has thrown the ball to the Chapter and the Chapter cannot help but accept the challenge. Thank you again, DAN.

Another event which brought together Easy Chapter members was the KANNEKH for TOSHIO "MAUI" OKAMURA which was held on August 4 at the DAV Memorial Clubhouse. Just about all the regulars were there with their wives plus REX KONNO and his wife. The Reunion headquarters will be the Maui Marriott Hotel in Kaanapali's resort area. 




