ECHOES OF THE PAST

Digging in on the ridge following the rescue proved to be no easy task as boulder after boulders were encountered and many were the shovels & picks that fell to pieces. The November cold didn't help the situation with the ground of this fertile forest starting to freeze up and getting to be as hard as rock. Next day orders, clear the ridge, this being the last day for the tank crew who took a direct hit right in it's belly. Regretfully, never got to thank the tank crew who joined us on one of the last banzai attack launched on this push. It was straight ahead on this ridge for the tankers while the K-men got their order to clear all the high grounds on the right of this objective, so never got to see how they were devastated. A recon patrol spotted a couple of machine guns supported by ground troops covering this area so it was a walk thru the woods once again in spread formation roughtly 10 feet apart advancing from tree to tree with no time to hit the ground. This is the day we lost our 90 day wonder Lt. Rainwater who joined us just a few days ago and who was turning out to be quite a soldier. Don't know where or how he earned his red badge of courage but this was the last we saw of this indian fighter. Every now and then can't help but wonder whatever happened to this likeable replacement. PART I

Veterans Day and Thanksgiving Day in the month of November are time for Remembrance and thanksgiving. Remembrance of those who gave their lives for our nation and thanksgiving for the many blessings we received over the years that perhaps could have been possible only under this nation. Some of our comrades were denied this day of thanksgiving only because of a cruel twist of fate Yoshiharu Aoyama, who volunteered from Heart Mouncain Relocation Center, was seriously wounded when a shell blew off both feet. At the aid station, Aoyama told the medics to tend to others first. In the darkness, the medics failed to see the seriousness of his wounds. Aoyama died from losing too much blood. Tetsuo Hamada, bright and carefree, from Puunene, Maui, together with some others was pinned under a prime mover and smothered when the vehicle overturned in a shell hole in the darkness. He was the only one in the crew who died. Some of the others were dugged out before they were smothered. Kiyuichi Matsumoto, one of our youngest cannoneers from Kailua, Kona, was driving Lt. Jack Earp on reconnaissance when shot by a sniper. Matsumoto was the Captain's jeep driver but was "borrowed" by the lieutenant for that mission. Sgt. Minoru Nakayama, from Alameda, California, was billeted in a house with Suyematsu and Imoto. Nakayama and Imoto were in one room with one bed and Suvematsu was in another room with two beds. They decided to switch rooms. A shell exploded in the room with two beds, killing Nakayama and wounding Imoto. We lament that they cannot share this Thanksgiving Day with us. (Narrative about our KIA's from Tooru Kanazawa.

After years of laboring with this column this end of the year report is being turned over to our prexy, TOWO UVEDA, reporting on the details of an extended trip taken following the NVR Reunion in Reno. It is an account of a very well planned tour by a group of four couples led by TOWO and his wife MARY.

A TRIP TO REMEMBER

In spite of warnings from others, the 8 of us; namely, Masami and Marilyn Doi, Neka and Hazel Matoi, Saburo and Tokue Ouchi and my wife, Mary and I, went ahead to plan for a long trip to the East and West coast of the states and both coasts of Canada. The trip consumed a total of 27 days for the Ouchi's, 37 days for the Doi's and the Matoi's and 40 days for the Uyeda's. This included 5 days in Reno for the Nisei Veterans Reumion.

We left Reno after enjoying the reunion, on the 12th of June to Washington, D.C. by way of San Francisco and Chicago. Arrived in the nation's capitol the following morning and made the Quality Inn-Capitol Hill our base of operations for the next 6 nights. It was hot and humid during our stay there and I swear that we lost some pounds. We visited the many museums and monuments in the city and also spent a day at the Colonial Williamsburg in Virginia. This historical site is becoming highly commercialized as compared to 8 years ago. I was a bit disappointed at this. We were able to visit the White House and the FBI building through the courtesy of Senator Dan Inouye's office and of course, a tour of the Capitol building, escorted by Dana from his office. The biggest moment came when the Senator hosted a private luncheon for all of us in the Capitol building, along with Mrs. Inouye (Maggie). What a lunch! This definitely was the highlight of our trip!

We left Washington, D.C. on Sunday, the 19th, to New York City via AMTRAK Metroliner. What luxury! First class travel was just great! Stopped off in Philadelphia for a few hours and was able to visit the Independence Hall area before continuing on to the Big Apple. Here we spent the next 3 nights, staying at the New York Penta Hotel on 7th Avenue and 33rd Street. Like all tourists, Empire State building, Statue of Liberty, Rockefeller Center and Broadway was a must. Riding the subway was also an experience in this busy city. The Ouchi's daughter and son-in-law was able to join us at the Statue of Liberty. What a dirty and smelly city!

On the 22nd, we left the big city and headed for Boston on the AMTRAK Club Car (reserved seats) and made the Midtown Hotel our base of operations. This city is very interesting with many historical places to see but the highlight was the Lobster dinner at a restaurant called the No Name Restaurant. This is not a gournet restaurant nor was it an attractive place, but the food was plentiful and the price was very reasonable. A lobster dinner cost \$13.95, Fried Scallop dinner was \$12.95 and the special Broiled Scallop dinner was just \$7.95. Good place for the big eaters! Ask Neka, Masami and Saburo about this place!

After 2 nights in Boston, the longest leg of our trip was ahead of us. On the 24th, we boarded the Vermont Bus Lines bus and left Boston at 10:00 a.m. After changing buses in Newport, Vermont, we arrived in Quebec City at about 8:30 p.m. and transferred to the Holiday Inn, where we spent the next 2 nights. The hotel was ideally situated since the shopping mall was alongside the hotel. This mall was created by blocking off 5 blocks of streets. Nothing fancy but seemed to be the gathering place of the people. Since, we only had I full day here, we were able to visit the Chateau Frontenac hotel, the Citadelle and the St. Lawrence River waterfront area only. There are about 95% French people living here where the French language is the main source of communication. Conversing with the people was a bit difficult.

We boarded the bus again for our journey to Montreal, the home of the 1976 Olympics. Upon arrival at the bus terminal, we noticed that some people were picketing the entrance. We found out later that this was in support of the strikers in the Province of Ontario. Due to the strike in Ottawa and Toronto, we were forced to change our mode of transportation from bus to riding the rails again via Rail Canada. Our hotel here was the Holiday Inn-Crowne Plaza, where we spent the nights of the 26th and the 27th. We visited the Chinatown area here which is located near the heart of the city and enjoyed a lunch of Won Ton Min. Shopping malls are located underground, just above the city subway system, and it is huge! Entrances were located at 4 major subway stations. The largest mall is called Place Ville Marie, which was near our

On June 28th, we boarded the train, reserved car, naturally, and left for the capitol of Canada, Ottawa. The countryside was very clean and nice, green and lots of fertile land. After arriving, we transferred via taxi to our hotel, Holiday Inn-Downtown. A very convenient location, what with the Farmers Market just

around the corner, Rideau Shopping Mall only 2 short blocks away. The Parliament Building and grounds was within walking distance from our hotel. The highlight here was the changing of the guards on the grounds of the Parliament, and was performed by college students during the summer months. Very impressive performance as the British are very proud of their heritage and traditions.

We left Ottawa on June 30th on our next leg to Toronto by train and transferred to the Delta Chelsea Inn on Gerard Street for the next 3 nights. All 8 of us joined a Gray Line tour to view Niagara Falls from the Canadian side, after sightseeing on the way there. After a delightful lunch at the Pillar Post Inn, we arrived at the falls. We boarded the Maid of the Mist for a wet ride to view the falls close up. Raincoats were provided but the lower part of our pants got wet. This visit to the falls is a must, especially from the Canadian side, where the view was much more impressive than from the American side. You will find here in Toronto, a vast underground network of shopping malls above the city subway system. It is huge! There is also a Chinatown, where we had to go to eat rice!

Finally, on July 3rd, the Ouchi's had to leave for home via Chicago. They were up early and left for the airport at 5:40 a.m. on the airport bus, to catch the United Airlines flight #323 leaving at 8:20 a.m. The Doi's, Matoi's and Uyeda's left the hotel at 10:00 a.m. on the airport bus to catch our flight. Upon our arrival at the airport, Canadian Air told us that we were not booked on flight #715 for Vancouver. After presenting our tickets to them, they realized that they had goofed and after conferring with a supervisor, they asked us if we would like to go with Ward Air and they would make up the difference in cost and also upgraded our tickets from economy to Business Class, which is first class on this plane. Heck, there was no objections from any of us and did we travel in style! Now we know how the upper crust lives when travelling!

After arriving at Vancouver International Airport at approximately 3:15 p.m., we encountered another problem. Gray Line of Seattle had not given us our vouchers for ground transportation, hotels, etc. After scrambling around and making numerous phone calls, we called the Quality Inn-Downtown and they confirmed that we did nave a reservation for our group there. We were able to reach the Gray Line of Seattle people through the desk clerk, who really helped us, and

The cultural things were great - the Great Wall while awesome was a disappointment in that there were just too many people - wall to wall of

If you see Iris, tell her I took her advice about carrying potable water around during the day and tried not to eat anything but piping hot food which was sort of difficult as I don't think the Chinese people believe in real piping hot food. I was happy to arrive in Hong Kong where we could drink the water and eat something other than Chinese food.

The holidays are fast approaching - tomorrow (November 3) would have been Dick's 74th birthday and since I was away from our daughter's (October 29), we're all going out this weekend to celebrate here as well as remember Dick's.

We spent five days in Tokyo just relaxing, getting up late, and visiting Ginza, Asakusa, etc. Randy Sakamoto who lives in Nagoya and Tokyo took us around on the weekend. We visited a district called Harajuku - a teenage hangout with rock

VA CHANGES PAYMENT POLICY TO ASSIST PENSIONERS

Sam Tiano, Director of the VA Regional Office, Honolulu, announced that the VA has amended its regulations to allow pension beneficiaries to receive monthly payments if less frequent payments cause loss of other federal benefits.

As an efficiency measure, the VA makes pension payments on a monthly basis only if the amount of the annual benefit is more than \$228. But for lesser amounts the payment is less frequent. VA pension checks are sent quarterly if the annual amount is \$144 to \$228, semi-annually if the amount is \$72 to \$144, and annually if the amount is less than \$72.

An unintended result of the consolidated payments, however, has been the denial of other federal benefits based on income, such as Medicaid, for the month the VA payment is received.

To avoid this result, the VA on March 11 changed its regulations to allow pension beneficiaries to request monthly payments if less frequent payments cause them to lose eligibility for other federal benefits. The request must be renewed each year and also must indicate which federal benefit eligibility is in jeopardy.

Pension recipients who wish to receive payment monthly should contact the nearest VA Regional Office.

VA pensions are paid to wartime veterans with limited incomes who are totally disabled, or age 65 or older, and to survivors of veterans who meet eligibility requirements. The amount of pension is based on income, and changes in marital or dependency status.



VETERANS CAN FILE NEW DISABILITY CLAIMS

Sam Tiano, Director of the VA Regional Office, Honolulu, announced that recent discovery of duplicate military medical records by the National Archives will enable thousands of World War II and Korean Conflict Army and Army Air Corps veterans to file for Veterans Administration disability compensation payments.

To speed these claims, the VA has introduced special procedures, collectively called Project Expedite, which involves a massive cross-checking of files to determine cases that can be reopened.

Mr. Tiano stated that by using the new records, VA benefits counselors now hope to assist many veterans whose claims had been denied because no record was available to confirm medical disabilities that occurred during military service.

The National Archives and Records Administration on June 15 advised the VA that it had located a collection of computer tape containing some 10 million Army medical records that partially fill a gap created when a 1973 fire destroyed millions of military files at a federal warehouse in St. Louis. The newly found records cover the years from 1942 to 1945 and from 1950 to 1954.

For certain veterans whose claims for disability compensation were denied since the fire, the VA may now be able to establish documentary evidence to support their claims.

The St. Louis fire destroyed or seriously damaged some 18 million service records, making future disability claims difficult and, in some cases, impossible to process. The newly found medical records were provided to the National Archives by the National Research Council, a private organization that had been engaged in analysis of Army hospital records in the 1950's. The computerized information reflects battle injuries treated in Army hospitals and a sample of hospitalizations for other reasons. The records cover personnel who served in the Army and Army Air

VETERANS OUESTIONS & ANSWERS

Q -- I am a service-connected veteran rated 10 percent. My service-connected condition has worsened. Can I be reevaluated for an increase of my percentage of disability?

A -- Yes. You should submit a written request to the VA along with any medical evidence you have to substantiate the claim.

Q -- Is there a time limit for applying for VA compensation?

A -- There is no time limit, however, the date of application is a factor in establishing the effective date of payment. In addition, it may also be more difficult to establish entitlement if a claim is filed long after the disability was incurred.

Q -- I served six months of active duty with the National Guard. Am I eligible for VA medical benefits?

A -- National Guard members are only entitled to VA medical benefits if they have a disease or injury which was incurred or aggravated in the line-of-duty while on active training.
