THE PRESIDENT'S MESSAGE

It was good to touch bases again with A.A.
"Bud" Smyser, an old friend, at the Punchbowl
Memorial service. Smyser, contributing editor of
the Honolulu Star Bulletin, and Mrs. Betty Smyser
were staunch supporters of the club in its early
years and helped us to establish a firm foundation in the community.

Bud Smyser's inspiring and thought-provoking Memorial address is printed in full elsewhere in this Bulletin.

The thrust of his message was that the KIAs being honored that day did not die in vain. The historic, overwhelming response of the Volunteers and the tremendous war record established by the 100th and 442nd left no doubt that Americanism is not a matter of ethnic origin but a matter of the "mind and heart".

He felt the 100th and 442nd gave impetus to a successful surge toward Statehood and full equal rights, eased ethnic tensions, and opened the road to the Aloha spirit. We helped to fashion "the most successful multi-ethnic community in the world."

But, he cautioned, it is not yet time to rest on our laurels. There is still room and need for improvement. A better, happier Hawaii calls for continued enlightened support. Bud had in mind our participation in the exciting, emerging Pacific-Asian era.

He quoted Dr. Victor Hao Li, president of the East-West Center, who sees a "critical need for Americans to better understand Asia". Unless Americans make a concerted effort to understand Asia's cultures, languages, societies and history, effective cooperation in all activities will not be fruitful.

Symser adds that Hawaii is ideally suited and situated to strive to fill this need. He solicits our interest and concerned support. He feels helping to establish Hawaii as the East-West intermediary place in the coming Pacific-Asian era to be a "logical outgrowth" of the dreams that motivated us in the World War II years.

Of major interest to many members is the Resolution adopted at the last Board meeting, requesting Hawaii's Congressional delegation to postpone implementation of the Medicare Catastrophic Coverage Act. The benefits provided by the law are supported but the method of payment for this program is of much concern. The cost starts at \$800 a year and is scheduled to increase annually, based on the income taxes you pay.

RURAL CHAPTER NEWS

TATSUO MIURA - January 25, 1916 - March 23, 1989, that's all that his gravestone may read. However, there is so much to say about Tatsu. His portrait at the altar in the Wahiawa Ryusenji Soto Mission where his memorial service was held on March 28, showed a smiling Tatsu Miura. I think this is the face that most of us will remember - that of a vibrant man. I think he was the original "Don't Worry, Be Happy" man who, no matter what the problem, would say "No sweat, can do."

Tatsu was one of the founders of Rural Chapter 442nd and a prime mover in the formative years of the Chapter. He initiated many of our fund raising projects that financed our picnics and Christmas parties in the younger, children raising years of the Rural Chapter members. He even donned the Santa Claus uniform with a pillow inside at the annual Christmas parties. An expert sign painter, and skilled at silk screening and stencil spraying he printed Rural Chapter's baseball and basketball uniforms, and shirts and T-shirts for members to wear to meetings and community functions. He gave freely of his time and also made a large monetary contribution to the Chapter. In his active days as a commercial sign painter many of the business signs in Wahiawa could be attributed to Tatsu. The largest and most prominent was the annual new car sales signs that he painted in multi-colors on the Service Motor show windows fronting on Kamehameha Highway in Wahiawa.

Tatsu Miura, like several others, was a "draftee-wolunteer." He was drafted and stationed at Schofield Barracks and volunteered when the call to form the 442nd was made. By coincidence he died in March - the same month in which he volunteered for the 442nd. At the memorial service Eddie Imamura gave the eulogy, Gary Yamaguchi spoke in behalf of Rural Chapter, Tadashi Matsumoto and Nobuo Takamori represented the Chapter in offering of incense. Other 442nd members offering special incense were Masaji "Shadow" Kurozumi representing Service Company, and Tatsumi Yamauchi, a very close friend of Tatsu. For fear of missing some names I will not attempt to list the many members of the 442nd who attended the service.

A better late than never item. All the incumbents volunteered to stay in office for another year so the 1989 Rural Chapter officers remain as follows: President - Tadashi Matsumoto; Vice President - Sam Kihara; Recording Secretary - Futao Terashima; Corresponding Secretary - Kenichi Sakumoto; Treasurer - Yutaka Kajiwara and Welfare - Nobuo Takamori.

You could have justified it on the basis of the treatment of internees of Japanese ancestry from the American West Coast.

But you didn't. And I think Hawaii's history is better and happier because you didn't.

To have refused, even if justified, would have exacerbated ethnic tensions in the islands.

- I don't know what else would have happened. But it is not too hard to believe that the move toward Statehood and full equal rights would have been set back.
- I can even believe that Hawaii today might be a U.S. commonwealth like Puerto Rico, rather than a state, or still a U.S. territory, or even a county of California as someone proposed.
- I don't know if our ethnic tensions today would be as bad as Fiji's. That would have depended on successor events. But I'm sure our community ethnic relations would hardly be as good as they are today. It might be hard to call us the land of the aloha spirit.

So the community owes you a great debt.

And so we can say with great conviction that your comrades who died in combat, and whom we particularly honor here today, did not die in vain.

* * *

That is a tremendous contribution. Few generations are so spectacularly challenged. And fewer still respond so magnificently.

You are assured a permanent place in the histories of these islands.

And you have added to that with outstanding postward records of individual accomplishment and community service.

* * *

By now you may have a hunch that what I am going to say next is that you nevertheless should still not rest on your laurels -- and that is right.

- I want to point to a new opportunity ahead. It is one that your World War II record helped make possible by building Hawaii into the multi-ethnic, harmonious place that we are. We aren't perfect in our ethnic relations, far from it. But we aren't so bad either. And what we have is simply the most successful multi-ethic community in the world.
- I have challenged people numerous times to name me another place where so many people of so many diverse races get along so well -- and never have had one named.
- Call it what you want. The aloha spirit is a good name. It is something intangible but immensely valuable. It is a little like breath, however. You only really appreciate it and miss it when you don't have it.

Now that quality can help Hawaii's people to capitalize on an opportunity that can enrich all our lives.

-- It can make Hawaii a more exciting place to live by stimulating sports, recreation, culture

-- It can diversify our economy.

It can provide more of the middle class jobs that today are in short supply.

-- It will stimulate education for all.

-- It will help eliminate the drain drain that forces some of our brightest young people to go to the mainland to see jobs.

-- It can be achieved without stimulating excessive growth.

-- And most of all it can further enhance our ethnic pride and aloha spirit, regardless of our backgrounds.

*

What am I talking about? Let me quote briefly from something Kenny Brown, businessman, architect and a close adviser to the late Governor John Burns, told a recent University of Hawaii graduating class:

"Both the Eastern and Western civilizations have been animated by the search for knowledge. The Western civilization has typically used this knowledge to control those elements of the world with which man interacts. Man pries out Nature's secrets in order to conquer her.

"In the East, on the other hand, knowledge has been more often used by man to help him conform with Nature rather than change her.

"Now these two systems are studying each other across the Pacific. And Hawaii, the product of physical geography, now finds itself in a crucial situation in a new geography -- the geography of ideas, philosophies and cultures.

'We are positioned between the two great cultural forces which face each other across the Pacific. Because we are a product of both...we are in a position of influence...

"We must make ourselves a welcome way station for those who now carry on East-West dialogue and commerce...We can create here a model society which combines the best in Eastern, Western and Polynesian values and techniques."

Let me quote also from Dr. Victor Hao Li, president of the East-West Center:

"A critical need is for Americans to better understand Asia. Unless we can substantially raise the level of expertise about Asia -- its cultures, languages, societies and history -- we cannot expect our country to work effectively with the region. Our capacity to deal with Asia and the Pacific is growing more slowly than the need."

* * *

Here, then, is a future role Hawaii is ideally suited to fill -- and to fill with all the advantages to our own people that I mentioned earlier.

In working for the last two years on a booklet called "Hawaii's Future in the Pacific:
Disaster, Backwater or Future State?" and on last December's Congress on Hawaii's
International Role I have come to a rather unexpected conclusion.

This is that the main thing standing between us and fulfillment of the role mentioned above is perception -- our perception of ourselves, and others' perception of us.

- Maybe I can explain it with one word, "Geneva". That probably conjures up images of economic and political conferences, summit meetings and a place for world-decision making. Only secondarily do most of us recall that Geneva is also a great resort city on a beautiful Swiss lake.
- Say "Hawaii" and different visions flash into minds around the world. Beautiful scenery, beaches and climate. Lovely dancers.
- Yet we have the potential to be an East-West intermediary as significant in the Pacific as Geneva is in Europe. We have the potential to serve the world and also serve ourselves. Not only in academic and business. But in sports, culture, arts, health programs, science, peace and mediation -- a whole rainbow of activities that, like tourism, could touch just about everyone in the community directly or indirectly.
- What we have to do is to recognize this, and then persuade others to recognize it, too.
- Last December's Congress recommended creation of a Hawaii International Action Commission in the Governor's Office to move us in this direction. A bill to do this is having a rocky passage through the 1989 legislature.
- If the Commission should emerge I hope its first key goal will be to work on this question of image. I would judge its year-to-year success by polls showing whether more people here and abroad are coming to recognize Hawaii as an East-West meeting place potentially as significant as Geneva.
- If they are, then I think a lot of the other things the Congress hoped for will begin to happen almost automatically in both the private and public sectors. International activity can then become a truly important segment of our economy -- hundreds of millions -- the newest adjunct since tourism. If you doubt that remember that almost one-third of our tourism income, comes from abroad, is already international, over \$2 billion.
- Most of that \$2 billion, of course, is vacation-oriented. But there is a big segment that is not. That is the segment I hope and believe we can build on to the advantage of all our people. It can be far bigger than sugar or pineapple or all agriculture combined.
- The Congress, incidentally, laid down strict Quality of Life guidelines to help us discriminate between businesses we want and those we don't want. Those we want would preserve the aloha spirit, show respect for our land and environment, help promote the physical and mental health of our people, include our disadvantaged people in their opportunities, try to talk things over rather than confront, and put into the community as much as they take out. You will note no tests were proposed for ethnicity or place of origin...just measures of conduct applicable to all. It is one of the few such codes ever adopted by a representative community group anywhere in the U.S.
- This is a cause in which you can help with your interest, concern and the prestige of your support.
- It is one that would not even be worth mentioning if Hawaii were a torn and divided community.
- It is a logical outgrowth -- in fact a very idealistic outgrowth and fulfillment -- of the dreams that must have motivated both you and your fallen comrades back in the World War II years.
- Hawaii a recognized East-West intermediary place serving both sides in the new Pacific Era. Hawaii...as much a part of the world as a part of the U.S. Hawaii, a place whose citizens of all races are very proud with much of their pride tracing back to the tides you set in motion back in World War II.

A NEED....MEMBERSHIP EXPANSION

John F. Kennedy once said, "...change is the law of life...and those who look only to the past or the present are certain to miss the future..." We concur with that statement and of the changes that inevitably will take place, even within our organizational structure.

Our Long-range Planning Committee was formally established in late 1987 to help direct such future changes in a more constructive mamner and not let changes occur in a haphazard, unguided way. And our planning process was aimed to harness the best thinking that exists within our own organization and, to some extent, from the community.

To this end, our Committee received from our members numerous suggestions and ideas that could eventually be incorporated into our future plans. One of the key issues was membership expansion, i.e., the need to promote the concept of perpetuity of life membership among members of the 442nd families. As early as 1956, our Charter and its By-laws flagged this as an important part our peace-time mission. By accepting this concept, it was felt that we could sustain our organization over the long haul.

Today, we find that such a goal was not attainable.

And there were a number of reasons for such a result. As someone mentioned recently, "...to generate interest among young nikkei's is no easy task...no longer is there an interest or reason to hold siblings to share the parent's life style or involvement in community or organizational affairs (in this case, with the 442nd organization)." And each tends to go their own way and doing their own things, a part of our heritage.

BUT WE MUST TRY AGAIN.

We must promote the concept of perpetuity of life membership and encourage our spouses and siblings to accept life membership in our organization. (Our By-laws allows such a transfer, one member per life member). We must show and tell them about the benefits one might acquire as a member of our organization and a chance to sustain the mission and purposes of the 442nd Veterans Club; of the potentials of an organizational base to plan, organize and direct a program to meet their own social needs as well as participate in community affairs; and of the advantage to utilize the Clubhouse and its facilities as a gathering place for group action activities.

WE ARE SURE SUCH GOALS ARE ATTAINABLE.

To ease the process to apply for such a transfer of life membership, the Committee has prepared a form (see elsewhere in this Bulletin) for your use. A second form is also available in case where the life member died without applying for transferred life membership.

Another idea about membership expansion emerged recently, the issue of establishing a new chapter for current sons and daughters of life members. It is modeled after the highly successful group, the Maui Sons and Daughters of 442nd Veterans. This idea enhances the concept of "transferred" life membership since both groups consist of young and viable members of the 442nd family. But, more importantly, it can be incorporated now. A core group of 40-50 members could initiate an attractive program of chapter activities, in our judgement.

This proposal seems like a viable option to expand our membership base.

Again we strongly urge all life members to discuss such an option with their sons and daughters and, if appropriate, encourage them to join and be a partner in the 442nd movement. A feedback to this issues will be welcomed by the Board.

KEYNOTE SPEECH AT "HOLOCAUST DAY OF REMEMBRANCE" AT PEARL HARBOR NAVY CHAPEL 12:30 PM - 1:00 PM, May 5, 1989

Chaplain Thompson, Members of Our Armed Forces, Veterans, Honored Guests, Fellow Americans:

Today, we are gathered here to remember the holocaust, the particular holocaust which was perpetrated on the Jewish people by Adolph Hitler in World War II.

To those who know, it is one of the blackest chapters in the annals of "man's inhumanity to man". I said, "to those who know", because there are many who don't know; and there are some who vocally, purposely, and stridently say that it never happened. The first-hand experiences of members of the 522 Field Artillery Battalion of the 442nd Regimental Combat Team at Dachau are part of the proof that says: "Oh yes, it did happen!"

Briefly, our time before the Dachau encounter was mostly in joint actions with the 442nd Regimental Combat Team which was an all-volunteer, all-Nisei outfit except for its Caucasian officers. There is much I can say about the many exploits of the 442nd Combat Team, but my allotted speaking time does not allow it.

Just before the Rhine River Crossing into Germany, the 442nd was split into two parts. The regiment of infantry and the company of engineers were sent back to Italy, while the artillery battalion was assigned to elements of the 7th Army to help with the Rhine River crossing. That was in early March of 1945. Once the Rhine River was crossed, and the Siegfried Line was breached; the front became very fluid. Artillery targets became scarcer and scarcer, fire-power became more and more concentrated and the rate of advance became a rat race. The situation was such that the artillery was often in front of the infantry. I remember our outfit traveling many times right on the autobalm, and in broad daylight with impunity. In the forest alongside the superhighways were Germany's latest aircraft, the brand new jet fighters, parked for want of fuel, ammunition, and pilots. Some were still in packing crates.

We were about 10 miles northwest of Munich and close to Dachau when we began to see people in prison garb all over the place. They were gaunt skeletons with only the skin over the bones and with eyes sunken deep in their sockets. Looking at them, one had to wonder how they were still alive. I was told that it was one of our 522nd's scout teams who were ahead of our main body who shot off the locks of the main gate to free the prisoners. By the time we got there, it must have been in the late afternoon and probably on April 29, 1945. After making our own camp, some of us entered the Dachau compound which was surrounded by a high barbed-wire fence, with prisoners still milling around everywhere and asking for food. Some of our men I was told took the time to look around at the crematoriums and the living quarters; others saw store rooms full of civilian shoes, clothes, etc.; and still others saw rail cars full of dead bodies. I can still smell the pervasive odors of death.

When I entered the Dachau compound myself, I recall going to the command building and there I remember seeing the Rev. Martin Niembeller dressed in the same prison garb of blue and gray stripes seated on a couch and apparently waiting for something. I recognized him immediately from pictures I had seen of him in $\mathfrak{m} y$ high school social studies classes. I was impressed on that occasion with the air of serenity about him.

In the course of that afternoon, I recall that we were all given strict orders not to give them any food. For one thing, there were so many of them; second, the battalion's resources at the moment were limited; and third, we were told that in their condition, they cannot handle ordinary food. We were told that more appropriate food would be prepared for them by our mess crews, and I believe that those orders were carried out.

When we sat down for chow that evening, we ate in our own Hq Battery area which was off-limits to the prisoners. Our food-scrap disposal sump, however, was at our camp perimeter; and there we saw many of them standing around watching each person scrape off the scraps into the sump. I did it too, and I still remember them saying: "W(V)arum? Why: Why are you throwing that food away?" It was hard, but military discipline, as you know, is very strict and hard, too.

In spite of the orders, I found out later that some had secretly fed some of the prisoners with improper food, and also that some prisoners had died. I learned too that some of our people saw other prisoners stripping and eating meat from dead horses along the road.

More recently in 1984, a large group of 442nd veterans visited Europe to celebrate the 40th Anniversary of the Battle of Bruyeres with the people of Bruyeres. In connection with that trip, those of us who were in the 522 F.A. Bn. of the 442nd made time also to visit Dachau in Germany. I think most of us, myself included, found that the Dachau Camp preserved as a museum for posterity was different from the one we liberated back in 1945. The layout was very different. It turned out that there were actually several separate prison compounds in the area all known collectively as Dachau. The publicity which followed our visit and the meetings we have had with Jewish officials and survivors there and in Munich, triggered a lot of interest of all kinds -- especially because the news stories mentioned that we were the liberators. Since that time, there have been claims and counterclaims by many American Army units saying that they were the ones who opened the gates, or that they were the first to reach Dachau, etc. They may all be right, but could be speaking of different Dachau camps. In the case of the 522's Dachau encounter we would not be able to say which camp, too, if it weren't for my remembrance of my encounter with the Rev. Martin Niemoeller. That encounter, I believe, has made possible the pin-pointing of the particular camp we were connected with because other records have also placed the Rev. Niemoeller in a particular Dachau compound from where he was transferred to another location at a particular time on a particular date.

In Hawaii today, there is a "Hawaii Holocaust Project" which is trying to record for posterity as much of the first-hand accounts as possible. You may contact Ms. Judy Weightman, a UH Law Professor and volunteer leader for further information.

In conclusion, let us all hope that mankind will never again see another Hitler, another Holocaust, and another 6,000,000 people processed thru extermination camps like the Dachau we saw.

(Incidentally, Chiyo's grandfather was an embroidery artist. He taught that art at Hart Mountain, Wyoming camp during World War II). Because Kumiyoshi had married a rich woman, he was no longer a starving artist, so he declined to teach Chiyo. Dr. Yusas, the first president of Japan's Christian University also enjoyed Oguri hospitality. Dr. and Mrs. Oguri have passed away. Their Brooklyn home has been sold. The children live in Kyoto, Honolulu, San Francisco, Los Angeles, and Saratoga Springs. Only one remains in New York City.

IN MEMORIAM

RONALD KOSUKE HIGA

January 9, 1922 - March 16, 1989

The first issue of the Go-for-Broke Bulletin featured the Ronald Kosuke Higa's fine family in the Livorno Chapter News. After the first issue went to press we received the sad news that Ronald died. With the permission of his widow, Janet, the eulogy given at Ronald's memorial service on Thursday, March 23rd, is published herewith. Pastor Harold Hedrick of the Honolulu Assembly of God officiated at the service held at Hosoi Garden Mortuary, assisted by Pastor Shigeki Kobayashi of Grace Bible Church. An overflow congregation of 500 participated at Ronald's service. Representing the Livorno Chapter, I served as the Master-of-Ceremonies and gave the eulogy.

EULOGY

Ladies and Gentlemen, it is with a sense of deep humility I am privileged to give this eulogy, honoring our dear friend, Ronald Kosuke Higa.

May I preface this eulogy with a familiar quotation from ecclesiates, Verse one and two, Chapter three: "To everything there is a season, and a time to every purpose under the heaven. A time to be born, and a time to die; a time to plant, and time to pluck up that which is planted."

We meet this evening under the shadow of a great loss in the passing of our beloved Ronald. Though the certainty of death, and the uncertainty of life is ever with us, each visit of the grim reality brings new sorrow, and humbles us in our daily struggle to survive.

Once again, necessarily, we should pause to reflect and consider the life and work of our dear friend, Ronald, and from his achievements seek to gain inspiration and courage to meet the trials and tribulations of our mortal existence.

As you know, Ronald died early Thursday morning, March 16th at Kuakini Medical Center. Sorrow fills our heart at this sad moment, a sorrow that is deep and very personal.

Ronald is survived by his loving wife, Janet Hatsue; a son, Melvin Morio; daughter, Lynette Leiko; three brothers, Koyu, Richard and Harry; three sisters, Mrs. Shizuko Chinen, Mrs. Jane Akiko Kumitake, and Mrs. Irene Sadako Teramoto; and two grandchildren, Stephanie and Barry. He is also survived by several nieces and nephews.

Ronald Kosuke Higa was born in Honolulu on January 9, 1922, the son of the late Mr. & Mrs. Kojin Higa. His dear mom, the late Mrs. Kame Higa, like all wartime mothers, suffered the worrisome anxiety while Ronald served as a replacement trooper to the 442nd Regimental Combat Team. Ronald was honorably discharged as a Technician Fourth Grade from the Army of the United States. He was among the replacement troopers who were given the distinct honor of bringing home the 442nd Regimental Colors to Hawaii after parading before President Harry Truman in Washington, D.C.

Ronald retired in 1986 after a long and faithful career with Aloha Petroleum, the successor to the Tidewater/Phillips Oil Company.

Memorial Service for Tatsuo Miura was held on March 28 at Wahiawa Ryusenji Soto Mission. Service Chapter members at the service were Masaji Kurozumi, Sam Yamada and Frances, James Miyake, Ralph Chinaka, Edwin Imamura, Takao Ito, Toshio Nakanishi, Toshio Dixon Yamashita, John Leonida, Hideo Nimori, Tatsumi Yamauchi, Kiyoshi Curly Muraoka, Masami Sashbrush Tanabe, and Alex and Jean Oka. Edwin Imamura presented the Eulogy and Masaji Kurozumi offered incense representing Service Chapter of 442nd Veterans Club. There were messages of condolence from U.S. Senators Inouye and Matsunaga.

During the war in Europe, Tatsu was with Lt. Rowlands to keep the supplies going to the men of the 2nd Battalion. He worked around the clock and often ignoring his own safety to deliver the much needed ammunition. In the book 'Americans -The Story of the 442nd Combat Team" by Shirey, Staff Sergeant Tatsuo Miura is credited with the Bronze Star and the Combat Infantrymen Badge. Not listed in the book for which Tatsu should have received credit were the Distinguished Unit Badge with oak leaf and the Purple Heart with oak leaf. He was wounded twice during the rescue of the Lost Battalion near Bruyeres. The first time was when a shrapnel tore through his sleeve and slashed his forearm. I learned of this injury when Tatsu was looking for a replacement shirt. The medics, in treating the wound, had cut off the blood soaked sleeve. A few days later, he received another shrapnel wound. This time it was in his calf. He had the medics patch him up so that he could continue with his work. His presence at the front was critical since Lt. Rowlands was also wounded and had to be evacuated. When my thoughts go back to October and November of 1944, I realize that the Great Lord Buddha must have been looking after Tatsu and the 2nd Battalion.

Former Lt. Tom Watts was a surprise visitor at the May meeting at the home of Ralph Chinaka. Tom retired as Lt Col and now lives in Boca Raton, Florida. During Camp Shelby days, Tom was the supply officer for the 1st Battalion. He was associated with the baseball team and he and his wife Doris served as chaperons when men visited the relocation camp of Jerome. After the 2nd Bn, 3rd Bn and special companies left Camp Shelby, Tom remained with the 171st. Later he became a transport ship commander shuttling troops to Europe and returning with prisoners of war.

On the health of members, Tom Tanaka is recovering from a virus attack on his nervous system. The virus was so crippling that he was unable to defend his title at the President's

The hotel we were booked in was across the Kyoto Railroad Station. That night we saw a man peddling noodles in a yatai. Too bad we didn't have a chance to sample his wares.

A city tour of Kyoto took us to the Ginkakuji (Silver Pavilion), Heian Shrine, Nijo Castle and the Kyoto Handicraft Center. However, the weather did not cooperate and the rain came down in sheets. The bus driver was telling us that the cherry blossoms were all but gone because of the rains.

Ginkakuji was built by Ashikaga Yoshimume in 1483. In contrast to the elaborate Kinkakuji built by an earlier Shogum Ashikaga Yoshimitsu, Ginkakuji has a monastic appearance throughout its gardens, teahouses and buildings. Yoshimasa had countless tea ceremonies and even today the spring water used by Yoshimasa is there. Soami, a renowned garden architect planned the garden. It became the prototype for all gardens and all gardens are patterned after his style particularly in positioning tea ceremony houses.

The next stop was the Heian Shrine dedicated to Emperor Kammu, the founder of the Heian Capitol. Brightly colored buildings are replicas of the first Imperial Palace though smaller in scale. Nijo Castle built by Tokugawa Ieyasu was our next stop.

Left Kyoto and headed for Okayama. Changed trains and arrived at the Kojima Station. Our hotel in Kojima had a magnificant view of the Seto-ohashi Bridge as well as the inland sea. At night you could see the cars going over the bridge.

The hotel van took us to the railroad station to catch the express train to take us over the bridge. Because we had ample time, the van driver gave us a view of the bridge closeup. The engineering feat that went with the construction can really be appreciated.

Went on a city tour of Takamatsu visited Ritsurin Park. Saw a variety of ironwood trees. Went up to Yashima Plateau and got a panoramic view of the city. We had the local specialty sanuki udon for lunch. The uniqueness of the udon was that it was served immersed in hot water in a wooden tub. The sauce was served from a tokuri and condiments of grated ginger and sliced green onions accompanied the sauce. That evening we went browsing through the shopping arcade of the city.

Enroute to Kochi prefecture drove along the Yoshino River. Kochi is very mountainous and the drive along the river very cliffy. The driver explained that when there is a storm, the river rises six to seven feet above its present level so the men who take tourists down the rapids constantly watch the water. As soon as the water appears muddy, the boats are taken out of the river. We had lunch at the Ryugado Grotto rest stop and walked through the cavern. Visited the center where the famous onaga-dori, long tailed roosters, are kept. The roosters are quite hammy and as soon as the cameras are pointed their way they pose. The caretaker explained that she has been having some trouble lately with the chicks. The tails drop off for some unexplained reason after they reach approximately 12 centimeters.

Visited Katsurahama. Katsurahama faces the Pacific Ocean and storms are common occurrences. Understand if you are in the area just prior to a hurricane, the stormy seas are quite a spectacle. Guess it must be like our North Shore during the winter. The statue of Sakamoto Ryoma faces the ocean along the beach. The arena where the famous fighting Tosa dogs perform are close by. We then proceeded to the factory where they made katsuo bushi. Visited also the paper museum where they make handmade paper.

Left Kochi and proceeded to Matsuyama. Visited the factory where they made tobe-yaki pottery. Visited the Matsuyama Castle. There were some remnants of cherry blossoms left but the night viewing of the blossoms were over so the castle ground were closed after 5 p.m.

Credit Union

QUESTIONS & ANSWERS

- Q. If a Hawaii credit union receives an out-ofstate district court subpoena for information, must the credit union respond?
- A. No. Out-of-state district courts have no jurisdiction over Hawaii credit unions. Such a subpoena must be filed through the Hawaii state court system, pursuant to the Hawaii Revised Statutes and rules of civil procedure.
- Q. If a member with an individual share account passes away, how does the credit union turn over the funds to the surviving spouse?
- A. If the deceased member's total assets are \$20,000 or less, the credit union must receive a "Small Estate Court Document" declaring the surviving spouse to be the true beneficiary to the funds.

If the estate is larger than \$20,000, it must be probated and the credit union must contact the administrator or attorney of the decedent.

- Q. What should a credit union do with a deceased member's individual share account of \$500?
- A. Attempt to locate the family and determine who is the true beneficiary. If that fails, the account is considred abandoned and eventually will be awarded to the state.





QUESTIONS AND ANSWERS

- ${\bf Q}$ Are the proceeds from National Service Life Insurance considered as income for VA's Improved Pension?
- A Yes, under the current pension program, proceeds are considered as income.
- Q Will the change on March 15, 1989, making the Veterans Administration the Department of Veterans Affiars affect my VA benefits?
- A No. The law making the VA a cabinet department only involves changing its name and making a few organizational changes. The new Department of Veterans Affairs will assume responsibility for all existing laws and regulations currently administered by the VA that provide benefits and services to veterans.
- Q My husband passed away and I filed a claim for his VA life insurance proceeds. Before the claim was received by the VA Insurance Center, his monthly premium was deducted from his compensation check. Will his premium be refunded?
- A Yes. Any premium payments made subsequent to the death of the insured will be refunded.
- Q My husband died and was buried in a VA National Cemetery. I was advised that I would be entitled to a total of \$450 as a burial allowance; however, I only received \$300. Why?
- A The \$450 burial allowance that was quoted to you included \$300 to be applied toward the veteran's burial expenses and \$150 as a plot or interment allowance. Interment in a National Cemetery was authorized in lieu of the interment allowance.
- Q I live on a very modest income and find it difficult to make my monthly National Service Life Insurance premiums. I don't want to lose the coverage. What can I do to reduce or waive premium payments but still retain coverage?
- A You may choose one of the following options: 1) To reduce the cost of premiums, you may reduce the amount of coverage, in multiples of \$500. 2) You may also apply your dividend to purchase paid-up insurance which would allow you to periodically reduce the basic insurance as new paid-up additions are purchased. Since the basic insurance would be reduced, the premium would be lower. 3) If you have a permanent plan policy that has a cash value it may be surrendered for reduced paid-up insurance. For example, a \$10,000 20-payment life policy effective May 1, 1980, at insurance age 50, would have a cash value of \$3,014.40 as of May 1, 1989. This cash value, used as a single premium, would purchase \$4,601 in paid-up insurance. Also, all National Service Life Insurance policies provide for waiver of payment of premiums for total disability starting before your 65th birthday.
- Q Is there a toll-free number for the Department of Veterans Affairs Insurance Center?
- ${\rm A}$ Yes. You can call the VA Insurance Center at 1-800-422-8079 if you have any questions regarding your insurance policy.
- ${\tt Q}$ Can I'use my VA-guaranteed home loan to buy land I plan to build a house on in the future?
- A- A VA-guaranteed loan cannot be used to buy undeveloped land unless it is part of a package that includes the building of your home.
- Q I receive education benefits from VA. Can I set up a direct deposit of those checks?
- A No. Only compensation and pension benefits can be directly deposited to a personal bank account.
- ${\tt Q}$ I receive VA disability compensation payments and would like to know why I did not get a W-2 form from the VA for income tax purposes.
- A VA compensation payments are not taxable and do not need to be reported.
- Q Can a veteran receive pension benefits from the VA as well as Social Security payments?
- A Yes. You may collect Social Security and VA pension payments as long as you remain within the appropriate income limitations.

Sam Tiano, Director of the VA Regional Office Honolulu, announced that most insurance holders and beneficiaries now can obtain immediate service on address or policy changes, dividend information, and other actions by dialing 1-800-422-8079 during normal business hours, 8:30 a.m to 5:30 p.m. EDT.

Those callers whose records may not be readily available will receive a return call or written response.

The phone service is made available through modern telecommunications that provide insurance specialists with instant computer access to premium data.

Dividends for VA policyholders are paid automatically to those who continue to pay premiums, usually on the anniversary date of the policy. No application is needed. More than 3 million veterans this year are sharing in the 1988 dividend distribution.

VETERANS CAN FILE NEW DISABILITY CLAIMS

Recent discovery of duplicate military medical records by the National Archives will enable thousands of World War II and Korean Conflict Army and Army Air Corps veterans to file for Veterans Administration disability compensation


To speed these cliams, the VA has introduced special procedures, collectively called Project Expedite, which involves a massive cross-checking of files to determine cases that can be reopened.

Using the new records, VA benefits counselors now hope to assist many veterans whose claims had been denied because no record was available to confirm medical disabilities that occurred during military service.

On June 15, The National Archives and Records Administration advised the VA that it had located a collection of computer tapes containing some 10 million Army medical records that partially fill a gap created when a 1973 fire destroyed millions of military files at a federal warehouse in St. Louis. The newly found records cover the years from 1942 to 1945 and from 1950 to 1954.

For certain veterans whose claims for disability compensation were denied since the fire, the VA may now be able to establish documentary evidence to support their claims.

The St. Louis fire destroyed or seriously damaged some 18 million service records, making future disability claims difficult and, in some cases, impossible to process. The newly found medical records were provided to the National Archives by the National Research Counsel, a private organization that had been engaged in analysis of Army hospital records in the 1950s. The computerized information reflects battle injuries treated in Army hospitals and a sample of hospitalization for other reasons. The records cover personnel who served in the Army and Army Air Corps.


