It was hard to imagine how cold a place can become, especially living in warm Hawaii. So Jane and I packed sweaters, thermal underwear, heavy jackets and insulated top coats. You can imagine how much room the warm clothing took up in the suitcases.

We left Honolulu on Jan. 30th at 9:00 a.m. via JAL. The returning Japanese tourists loaded themselves up with "omiyages" from the Duty Free Shop. Judging from the number of packages and goods carried on board by them, the State of Hawaii would like to thank them very much for the thousands of dollars spent by them. Our tour group was fortunate in receiving "Executive Class" seats, which were wide and spacious and seated 2 abreast. JAL's flight service was excellent, as compared with our American airlines, which fly between Hawaii and the Mainland.

We finally arrived at Narita Airport after approximately 8 hours of flight time. After clearing customs and immigration we were able to leave for our hotel in Tokyo, a distance of about almost 2 hours by bus. We were surprised at the relatively mild climate (not snowy, as expected). Our hotel, the Sumshine City Prince Hotel, is a huge hotel, located in the Ikebukuro Area of Tokyo. Since it had restaurants and shops in the building, we didn't need to go outside for anything.

We departed from Tokyo the next morning on a chartered bus, exclusively for our group of only 15 people. As a result, everyone was able to occupy one seat, which normally seats two persons. The first snow flurries were falling, as we departed Tokyo. Everyone seemed excited upon seeing snow, because, for some, this was their first experience with snow. We had a whole day of bus ride with rest stops and lunch break included. When we finally arrived in Niigata, we stopped at this shop which had many kinds of shoes, especially "snow pack shoes". All of us who needed them purchased a pair. One needs this type of shoe when walking around snow covered grounds, because the orginary shoes cannot give enough protection against the snow from entering the shoe. These shoes are like boots, but much lighter and made of plastic or hard rubber and lined with a flurry substance, to keep the feet warm. The front zipper enables one to tighten the grip on the feet.

The next day we stopped at a lake where there were thousands of swans and ducks, which fly in from Siberia each winter. It seemed strange that these swans and ducks would fly to a location where there was lots of snow and ice, but I guess, it must have been warmer than Siberia. There is a person at the lake who feeds these swans and ducks and the local government helps him in defraying the cost.

After two snowy days, the third day turned sumny and beautiful and we were fortunate to see some magnificent sights atop Mount Zao. We went by cable car to the top of the mountain, along with many skiers, carrying their skis on the cable car. The trees on top of the mountain were covered with snow and ice, so that they looked like snow mounds rising from a few feet to over twenty feet in the air. They looked like pictures of the moon landing areas - somewhat eerie.

We stopped along the way to experience onsen (hot spring), where we were able to bask in the hot water in community style bath. We also sat on the tatami mat to eat Japanese style. My stiff knees made it very difficult to sit cross legged and eat from the tray set before you. I finally gave up trying to sit cross legged and stretched my legs even though it didn't look too good.

We travelled by bus everywhere we went, except one segment of the trip. We went by train from Aomori to Hakodate in the underwater tunnel, which was recently completed. This tunnel connects Honshu and Hokkaido and is supposed to be one of the world's greatest engineering accomplishments.

After arriving in Hokkaido, we started seeing the many "snow festivals". I was surprised to learn that these "snow festivals" are built and observed by many towns and cities. The climax of all these snow festivals was in Sapporo, where there are ice carvings and statues stretched over approximately a 10 block area. Some of the carvings are huge and replicas of buildings, which look like state capitol domes, while others are smaller and exquisite.

One display which was breathtaking was located in Sounkyo, where they carved ice in huge settings. As you walk through the tunnels connecting one display with another, it seems like you are in an ice box and it feels eerie, as you think - what happens if the ice were to crack and bury you in the tunnel.

One interesting side light of the trip occurred in the town of Noboribetsu, where we were in a Japanese style hotel, with onsen and all. As we were eating dinner in a huge dining room, many other tour groups trooped in. Some of them looked like Hawaii people, so we looked closer and saw this husky guy in a Japanese Yukata. It was none other than Tom Kiyosaki. After exchanging pleasantries, he left for a short while and returned with a copy of the Honolulu Advertiser, which he gave me. Reading a home town paper after over a week of Japanese newspaper, was such a treat, that the paper was passed to many hands in our group, before it was discarded.

Hauoli Makahiki Hou! Happy New Year -nearly three months later, how time flies!

Our Cannon Chapter reporter, Henry Chagami deserves a break -- so here I am trying to get this article out on time, before it's due. As usual I'm procrastinating!

I vividly recall Captain Shorey's Christmas message a request to write brief biographical sketches on each Cannon Co. member ... Henry may want to pursue this project but I don't think I could get the boys to tell me about themselves, in other words: the Cannoneers become shy when there's a chance of seeing themselves "in print."

February 27th was one of the most interesting "talk story" session with Dorothy Matsuo at the clubhouse. Dorothy is gathering information for a book on the members of the 442nd RCT. I suspect it's a great task -- a rather personal account of the unique personalities of the men of the famous AJA outfit. The evening's session is the second meeting, the warm rapport was much in evidence. Dorothy's skillful interviewing technique was obvious. Members present were Curley Muraoka (the president of Cannon Chapter), Charles Oda (442nd lst Vice President), Kaoru Watanabe (Chapter Treasurer), Tom Okino, Henry Chagami (Past Chapter President), Mamo Morita and Masami Ohara.

The interview was being taped at the large conference table while I sat by myself at the round table with a supply of stationary to catch up on some long-delayed correspondence. I tried as hard as I could but found my ears stretching to hear the "boys" conversation. Did you know that Tom Okino was only 5 feet tall when he joined the Cannoneers at Camp Shelby and that he was an orphan? The boys teased Tom that the Army chow must have been great and agreeable to help his growth spurt to outgrow many of his buddies by the end of the war. Who was the cook? Jusey Kaneshige or Yosh Terashima? I thought the best story teller was Kaoru Watanabe -- you must ask him about the time he was mistaken for an Army General soon after arriving home after the war. And Mabel I understand now why he's such a good housekeeper. He put in more than the average student houseboy's duty hours while attending the university as a freshman soon after graduating from Maui High School. Curly Muraoka shared his tales of his youth as a member of a Pawaa gang ... the excitement at Bon Dances many times ended the girl meet boy event with fights between different gangs. There were the Sheridan, Palama, Kakaako and country gangs. There were social dances at the Armory, different gyms which were even better places to meet the girls. Charlie Oda mentioned

that he was an active swimmer in high school as well as in the army. Mamo Morita enjoyed training under Richard Chinen in the boxing team. Henry Chagami was reliable for getting the boys back on track and provided appropriate resource materials, among them writings by Captain Shorey and Tooru Kanazawa. Masami added that he hesitated to tell his father of his volunteering for the all-Nisei force. His father stood silently for a while and expressed his relief over his chance to be sent to Europe and not the Pacific theater of war. Much discussion centered over the selection of boys from the various units to form Cannon Co., about six months after basic training at Camp Shelby. Henry Chagami said he remembers Tetsuo Hamada and he were sent to Cannon Company because of their background knowledge in communication. Masami added that Captain Shorey and Harold Nakasone "combed" each company to "hand-pick", in other words that every man came "highly recommended" into Cannon Co. Nevertheless you'd agree that Cannon Company is made up of a very diverse yet interesting group of men. Dorothy Matsuo more than once emphasized that with so many, many stories, it would be impossible to include all the stories in her book. Surely it would be an overwhelming problem of selection. The spontaneous oral sharing of the evening should itself be enough to fill a book for Cannon Chapter. Any volunteers for the project? I overheard the boys mention there were a string of camp followers who waited for the left-over foods thrown away at the mess halls or the kitchen tent. Many touching stories too -- like Donald Higa's love of children -- he didn't want to see the children starve, perhaps they reminded him of his own child left in Kauai. A few boys took regular time-outs to shampoo and comb the little childrens' ulu-infested hair ... the session was going strong till 10:00 P.M. Charles Oda brought his handsome albums for Dorothy's use. Had we known Dorothy's request for resource materials, we would have gladly shared Masami's folder which include Captain Iwashita's resume and Tim Osato's memorial news article which was sent by Arthur Doi. Tim Osato had a brilliant army career and was a lecturer and authority on China. Thanks to Dorothy and the Cannoneers it was a most meaningful evening, although my letter writing remained untouched.

Of interest ... the Cannon Company sends deepest sympathy to Mutt Kusatsu and his family on the loss of his beloved wife, Emi. I heard from Judy Saiki that it was a very beautiful memorial service at the Church of the Crossroads. The Memorial service was prepared by Emi with her selection of favorite hymns and the request of her minister, master of ceremony and for Melvin Furukawa, her boss and principal to deliver her eulogy. Rodney Fukui lost his father recently. The funeral service was held at Hosoi Mortuary.



1989 ANNUAL REPORT OF THE BOARD OF DIRECTORS TO GENERAL MEMBERSHIP, 442ND VETERANS CLUB FCU

Welcome to our 35th Annual Membership Meeting! Your Board of Directors is pleased to submit this memorandum highlighting our accomplishments for 1989 and plans for 1990.

As noted in the Treasurer's Report, our loan portfolio at year-end showed some increase as compared to prior years. Our savings balance is essentially holding steady. Perhaps the bright spot on our balance sheet is the fact that our reserves and undivided profits have substantially improved to \$313,332. This amount is equal to a ratio of 15.3% of total savings as compared to last year's 12.9%. This achievement was possible because of our continuing improvement in profitability over the years—particularly in 1989.

We paid a dividend of 6.0% during the first, second and fourth quarter of 1989. In celebration of our 35th Anniversary, a dividend of 7.0% was paid on September 30. Even though our credit union offers only minimum basic financial services, we plan to pay as much as is prudently feasible on your savings.

Last year we announced some reduction in our loan rates. This year your Board of Directors is most pleased to announce that we will underprice, undercut any financial institution in the country. Effective January 30, 1990 all 1989 interest rates will be slashed one full percentage point! We anticipate keeping these reduced rates for the rest of 1990. But you must understand that your Board of Directors reserves the right and has the duty to reconsider should circumstances require!

The only not-so-good news is that, for only the second time in 35 years, we deemed it necessary to write off two very delinquent loans. The net chargeoff amounted to 8736. This is a very minimal amount considering the fact that we made over 5,375 loans and granted almost \$8 million in loans since our organization. Currently we do have two delinquent loans; however, the balance represents only 3/10 of 1%—way below the experience of most credit unions. We believe these delinquencies will be corrected shortly.

Even though the reduced loan rates for 1990 will mean lesser loan income, we are confident that we can continue to operate profitably—with cost controls and prudent investments.

### A MEMORIAL

We were saddened to learn that Masao Maedo of Hilo, Hawaii passed away recently. It happened on new year's eve while playing cards with relatives, he had a massive heart attack and died several hours later without regaining consciousness. He retired from work several years ago from Hilo Motors, where he worked as a mechanic. Not a golfer, instead went into raising orchids and carps.

Having been in the same squad and platoon for several years, feels as though we knew him as well as anyone, we think. A quiet but not shy person by nature, he never was one to bitch or grumble and was a good soldier with character. Did everything asked of him and more if could. Just the opposite from a holler guy and never was one to leave anybody holding the bag. He never was one to beg or back off should anything come his way. A reserved person, he never was one to get things started but was always there and willing to join in and participate.

Met him only once since army days. It was on earlier visit to the Big Island back in 1947, looked him up where he lived (then) in Panaewa and he took us on a leisure tour to see the black sands of Kalapana and the Volcano area. He was a respected man and never did hear anything derogatory or negative about him. One of many description of him would be, in case of a fight, you would want to be on his side. He was one of the boys that was called by the last name, hardly by the first. Was for the better because the Co.'s personnel listed several Masaos.

He being a man of few words and no nonsense guy, brings this incident to mind and vividly recalls all the details as though happened only konaida. It took place after all the hostilities went pau back in '45 in Italy and the boys awaiting shipment to go home. We (part of 3rd squad, 2nd platoon) were assigned the duty of operating a waterpoint in San Juliano, a small rural village not far from Lucca, the famed walled city. Anyway, late one night, no, make it early one morning, a weapons carrier full of yotakure Beanies (haole G.I's) apparently fast running out of fuel after a long night of raising hell and painting the Italian countryside red, was trying to sneak and cacaroach some benzine from our fuel storage. Caught in the act with their hands in the cookie jar, the leader, so it seemed, sort of humbly to no

one in particular asked, "Can we fill'er up?" or something to that effect. Maedo answered 'No".
Da Beanie getting cocky: "Aren't we in the same army?" Maedo, "Yeah." 
