

The rank is an order above full professorship and has three coequal designations: Distinguished Professor, Distinguished Service Professor and Distinguished Teaching Professor.

Kenneth, a faculty member since 1969, is internationally recognized as one of the world's foremost authorities in the field of Buddhism and Far Eastern thought. In 1990, he was the second American in 150 years to receive the prestigious Bukkyo Dendo Kyokai's Cultural Award from the Tokyo based Japanese Foundation for the promotion of Buddhism in recognition of his distinguished career in Buddhist studies. He received the award at an elaborate ceremony in Japan attended by prominent diplomats and scholars from many Asian nations.

Ken is also the author/editor or translator of six books, 11 book chapters and dozens of jour nal articles in his field. He is noted in particular for his distinguished translation and for his commentary on Nagarjuna's Malamadhyamakakarikas, a work that is seminal in Western studies of that Buddhist thinker. We certainly must have Kenneth for proper reading on the Buddhist thinker when he comes for the reunion, that is hopefully he'll come.
