

Since the 2nd quarter report of the 442nd newsletter was due for typing in April and that report constituted report of chapter activities from December 1, 1992 to April 30, 11993, this report is about Easy Chapter acitivities from May 1, 1993 through August, 1993. This consolidation of the 1st and 2nd quarter reports of chapter activities by the editorial staff of the newsletter was done because the demands of the 50th Anniversary events did not permit the staff to print the first quarter newsletter. In addition, it gave the chapters and the newsletter staff the opportunity to include reports on accounts of the 50th anniversary events in the one combined edition of the newsletter. Mahalo and kudos to the staff for the oversized newsletter.

For Easy Chapter it has been a lull of activities following the historic 50th anniversary celebrations. The Chapter has had two dinner meetings since the celebrations. Somehow dinner meetings bring out more than double the attendence at monthly meetings. This is because dinner meetings include spouses as well as widows of deceased chapter members. In this connection the chapter has officially welcomed widows of chapter members as duespaying members of the chapter. We believe this is a proper thing to do as widows of chapter members have much to contribute to Chapter activities. We however have not had much luck with our children. This is an area where the chapter will have to be more aggressive in getting our children involved in the Sons and Daughters Chapter of the Mother Club. After all, our days are numbered and the next generation will have the responsibility to keep the tradition, accomplishments, and name of the 442nd Regimental Combat Team a matter of living history.

Coverage of the 50th anniversary events as well as of the books written of the 442nd story somehow gave scant mention of Easy Company contributions to the war except those of our senior U.S. Senator DANIEL K. INOUYE. This is partly the fault of Easy Chapter members as we failed to volunteer our stories as well as failed to actively seek ways in which we could contribute to the total effort. This matter of the lack of visibility of Easy contributions to the war effort was brought up at one of our dinner meetings by a spouse who was reading THELMA CHANG'S book "I Can Never Forget: The Men of the 100th/442nd.

Chapter members are usually not anxious to discuss their WWII exploits except when in friendly company. Many of them wouldn't even know what to say or do when confronted by strangers. The spouse's contribution of that dinner meeting raised the the level of interest of spouses wanting to know more about what their spouses did during the war. This writer knows that we have many very brave men in the chapter who were awarded medals for valor in combat as well as many, many who were awarded purple hearts for wounds received in combat. The result of this this genuine interest has prompted the chapter to delegate this writer to make initial contact with author THELMA CHANG with the hope that the chapter can collectively and individually come up with a story of Easy Chapter's contribution to the war. With this in mind THELMA CHANG has been invited to speak to the chapter at the chapter's Christmas Dinner in December.

Now from some news about chapter members. Although this writer does not like to say too much about his family, he would like to announced that his son MICHAEL may be in a position of help chapter members with chronic back aches and the like because at age 41 he became a Dr. of Chiropratics in Los Angeles which was attended by his whole family. Another piece of information of interest to chapter members concerns spouse KUULEI, who is a crew member of the Hawaiian Canoe Group. Last spring she flew to Tahiti and sailed on the Hokulei between several of the Society Islands. When the recent hurricane approached the islands she was on alert status should the need

arise to get the canoes out to sea. As a crew member she is also in training to develop her upper body strength so that she could stay afloat if she falls overboard or the canoe capsizes. From this she swims regularly in the waters off Elks Club Waikiki as well as lifts weights.



## COMMITTEE REPORTS Archival Committee by Ted Tsukiyama

"Loyalty Screening for 442nd"

Did you know that all of you 442nd inductees in March, 1943 were subjected to a loyalty screening before being accepted?

While the War Department magnanimously announced it would open up military service to Japanese-Americans in an all AJA combat unit, it was subject to the secret condition that all volunteers pass a litmus test for loyalty. This astounding fact came to light in papers submitted by TOM KAWAGUCHI (Co. F) to LYN CROST STERN for her book about the Nisei soldiers (100/442/MIS) titled Honor by Fire.

Analysis of Chart of Special Questionnaire Relating to Citizens of Japanese Ancestry Who Make Application for Voluntary Induction into the Army of the United States for Service with the Combat Team.

Question 1: Name (If first name is anglicized and Japanese given name is no longer used, 1 point in favor. If Japanese given name is used, 1 point against.)

\*Question 3: If place of birth is Japan, rejection made since only citizens are eligible.

Question 7: If a registered voter, 1 point in favor. If registered in first national election subsequent in his coming of age (here see date of birth), 1 point in favor. If registered in the Communist Party, rejection must be made.

Question 8: If married and wife is American

citizen, 1 point in favor. If citizen of Japan, 1 point against.

Question 9: If father born in Japan, no score. If father born in United States, 1 point in favor. If mother born in Japan, no score. If mother born in United States, 1 point in favor.

Question 11: If a relative is in US military service and a volunteer, 2 points in favor. If in the US military service and a selectee, 1 point in favor. If father has been interned, refer case to officer.

Question 12: If parents are in Japan, 3 points against. If brothers and sisters are in Japan, 2 points against. Brother are of more influence than sisters. Collateral relatives in Japan, 1 point against. If collateral relatives are in Japanese military service, 2 points against.

Question 13: If subject attended Japanese kindergarten, 1 point against. If subject attended American grade school, no score. If subject attended Japanese language school, 1 point against. Length of time is very important here. If he continued language school while in high school, it shows less Americanization than if he told parents he now didn't have enough time to go. Also in the higher grade he gets more Shinto-Yamato race instruction. If subject attended American high school, 1 point in favor. If subject attended American University or College, 1 point in favor. If subject had ROTC, 2 points in favor. If subject has had Gunji Kyoren, reject him. If subject has had post-graduate work in Japan, 1 point against. However, if subject has had all his grade school, high school, and college work in the United States and has had but one year's post graduate work in Japan, 1 point in favor. He should be sufficiently educated toobe disgusted with Japan and normally is. If applicant has resided in Japan for six months of more over the age of 12, refer him to an officer. If he resided in Japan while of military age (between 16 and over) and denies military training or Gunji Kyoren, refer him to an officer (Note by CCP: He's a d—m liar. Gunji Kyoren starts in middle school - age 15 or 16 and over - compulsory military service starts at 20 and is for 2 years).

Question 14: If subject has traveled to Japan once, 1 point against. If subject has traveled to Japan twice, 2 points against. If subject has traveled to Japan three or more times, reject him. If subject has traveled extensively to Japan or elsewhere for semi-official firms (such as Mitsubishi or a Mitsui firm, reject him. If subject traveled by Japanese naval tanker, reject him. If subject traveled by Japanese ship, 1 point against. If subject traveled by Allied ship, 1 point in favor.

Question 15. If subject worked for a semiofficial firm such as Mitsubishi or Mitsui organizations, 2 points against. Fisherman, 1 point against. Licensed amatuer radio operator - 2 points against him. If a sea-going radio operator, reject him. Hotel owner or operator, 1 point against. Taxi driver, 1 point against. Importing and exporting businees, 1 point against. Merchant marine, 1 point against. Agriculture (includes truck farms), 1 point for him. Mine, no score. Stell foundery, automobile, hearvey machinery worker, 1 point for. Steamship line, 1 point against. Newspaper man for American-Japanese newspaper or periodical, 2 points against. If for Japanese newspaper or periodical published in Japan, 3 points against. Employed by Japanese governmental agency, reject him. Japanese language school instructor, 3 points against.

Question 16. Christian, 2 points in favor. Buddhist, 1 point against. Shintoist, 2 or 3 points against. Worships regularly at Shintoist shrine, reject him.

Question 17. Membership in Japanese-American Citizenship League, 2 points in favor. Membership in any of the attached list of Japanese organizations (he shouldn't belong to these if he's a Nisei), reject him, especially Heimusha Kai and Dai Nippon Butoku Kai. If a member of a Kudo, Judo, or Kendo club, 1 point against. If a member of two such clubs, 3 points against. If a member of a Japanese correspondents association, 2 points against. If a member of the CIO, 1 point against.

Question 18. Facility in reading Japanese, 2 points against. Speaking Japanese, no score.
