I. CHANGE IN NAME

After reviewing the minutes of the meeting of 1/16/85, it was noted that JACL (Board) and JASSI felt the name that had been addopted was inappropriate and did not reflect the intent of the groups that had come together this year to jointly co-sponsor the Day of Rememberance Program. Since the primary agreement reached at the last meeting was to co-sponsor this years program, we reached a consensus to change the name of the umberella sponsoring group to:

II. PLANS FOR THE DAY OF REMEMBERANCE PROGRAM

A. Acknowledgements for Redress Efforts
Kim presented a draft of the invitations to be sent to individuals and groups to acknowledge their efforts in redress; and the committee addopted her invatation.

Each organization and members of the committee were asked to supply Kim with names and address of Acknowledgees; and the invitations will be sent as part of a larger mailing on Thurs., February 7. We agreed to print 100 invitations.
