Will Putting Aliens in Jail Solve Unemployment?

Newspapers are featuring scare headlines about aliens depriving us of jobs. The House Committee on Immigration is holding hearings in NYC on a Nixon administration bill, H.R.2328, with dangerous and unconstitutional provisions.

NIXON AND IMMIGRATION OFFICIALS SAY:

Illegal aliens are flooding the country and depriving the unemployed of jobs.

Employers who hire noncitizens without asking whether they are entitled to work should be criminally liable. (HR 2328 Sec.26).

Nonresidents found working without permission should be criminally liable (Sec.28).

Commissioner Farrell favored "Identification cards" for ALL citizens, so that aliens can be singled out.

THE FACTS BEHIND THE PROPAGANDA ARE:

Immigration Commissioner Farrell admits that 97% of illegal aliens are Mexicans in the southwest. In 1970 there were 8548 deserting foreign seaman. Are they the main reason why 5½ MILLION Americans are jobless ?

This would involve everyone in hunting down illegal aliens and create a climate of fear. Employers are already refusing to hire any noncitizens, including permanent residents. Is this fair ?

Such persons are presently subject to the punishment of deportation. Shall we also treat nonresidents seeking a livelihood (many of them married to US citizens and with citizen children) as criminals ?

Congressmen Dennis (Rep. Indiana) and Eilborg (Dem. Pennsylvania) call this a "police state" step, an "internal passport" for complete government control over the people. This I.D. card is unconstitutional and undemocratic.

The Nixon administration proposals are a smokescreen and a hoax: (1) to cover up the fact that NO REAL MEASURES are being taken to provide for jobs; (2) to pit native and foreign born workers against each other; (3) to violate the constitutional rights of citizens by requiring ID cards.
