INDICTMENT



We, the people of the Lower East Side of New York, by this indictment, accuse the Government of the U.S. of responsibility for the crime of murder of some 300 unarmed civilians in Songmy, Quan Ngai province, Vietnam.

We believe the U.S. intervention in Vietnam to be illegal and unjust.

The atrocities in Songmy and similar horrors have occurred again and again because the war in Vietnam is being conducted against an "enemy" who cannot be distinguished from the people.

We accuse the Pentagon of responsibility for the brutalization of our soldiers, including the indoctrination of racist attitudes toward all the Vietnamese people, which is an inevitable consequence of American intervention.

We accuse the giant corporations, ever hungry for greater profits from the exploitation of colonial peoples, of direct complicity in all of the aforesaid charges.

We accuse the U.S. Government of deceit and cowardice in claiming innocence of this massacre and putting the entire blame on the shoulders of two servicemen.

Finally, we accuse the U.S. Government of ravaging our cities, which we on the Lower East Side know well, and depriving our people of desperately needed services by constantly siphoning off funds for the war.
